

Notices for \$449.5 Million in Unpaid Taxes Sent to Owners of More Than 136,000 Properties Across Cook County, Pappas Says

Delinquency notices have been sent to owners of 136,104 homes and other property who still owe a total of \$449,579,199 in unpaid taxes on bills issued this year, Cook County Treasurer Maria Pappas said today.

If the bills remain unpaid, state law requires that they be offered at the Annual Tax Sale in the first week of April of 2017 – with 1.5 percent interest added for each month of delinquency, Pappas said.

In the event their unpaid taxes are sold, taxpayers must repay the entire delinquent balance in full, plus additional fees and interest, or possibly lose title to their property, the Treasurer warned.

Twice yearly, the Treasurer’s Office mails

about 1.8 million bills for an annual total of about \$13 billion, then distributes the collected property taxes to local taxing districts. These notices are for Tax Year 2015, which originally was billed in two installments, due March 1 and August 1 of 2016, respectively.

Pappas said delinquent property owners can use credit cards or debits from their bank accounts to cover unpaid bills by visiting cookcountytreasurer.com and clicking on “Make an Online Payment.”

Payment also can be made at any Chase Bank location; at some community banks; by mail; or at the Treasurer’s Office at 118 N. Clark St., Chicago, Room #112.

Governor Signs Bill Creating Police Dog Retirement Act

Governor Bruce Rauner took action on SB 3129, creating the Police Dog Retirement Act. The act will allow all K-9 police dogs that are deemed no longer fit for public service to be offered first to the handler on the force. The Governor signed the bill on First Responders Day at the 2016 State Fair during a ceremony at the Illinois State Police Tent.

“They may not look like our typical officers, but K-9 police dogs are crucial to how our first responders do their jobs,” Governor Rauner said. “They are partners and team members. They quickly become a part of the family, and they should be allowed to stay with that family, even after retirement.”

“Canine handlers and their partners form a special bond as they face many challenges together,” said ISP Director Leo Schmitz. “The signing of the Canine bill recognizes this special bond and provides both the handler and the canine the ability to remain together following their service to the citizens of Illinois.”

City of Chicago Coordinates Yard Waste Pick-Up to Help Collect Fall Leaves and Debris

As part of the citywide effort to clean up leaves before winter, the Department of Streets and Sanitation (DSS) is coordinating dedicated bagged leaf and other yard waste collection trucks this fall to assist residents in clearing their yards, parkways and storm drains to leaf debris.

Residents can call 311 to request separate bagged leaf collection from October 17 through November 30.

Leaves and other yard waste should be left in the alley or at the curb for collection, and bagged separately from garbage in the

black carts and separately from recycling in the blue carts. A DSS truck will collect the bags based on 311 requests and take it to be composted.

DSS will continue street sweeping throughout the fall to capture leaf debris in city streets and help prevent draining issues during the winter. Residents are also encouraged to clear curb lanes and areas around storm drains.

Village of Skokie Leaf Collection Begins and Yard Waste Collection Ends

Regularly scheduled yard waste collection for the 2016 season concludes after the November 9, 2016 collection. On Monday, October 10, 2016, the Village begins its annual leaf collection program that continues through early December, weather permitting.

Instead of bagging, or for those who do not mulch leaves, residents may rake leaves into the street next to the curb in front of their home. Residents are reminded not to place their leaves in the street prior to the beginning of the leaf collection season. As weather permits, Village crews make rounds throughout Skokie collecting the leaves on a five to seven day basis.

Please follow these tips to insure collec-

tion:

- Rake leaves away from parked cars and do not park on leaf piles.
- Be mindful of fire hydrants and keep them visible.
- Wetting leaves while piled prevents them from blowing away.
- Do not rake leaves onto or in sewer drains.
- Please do not add grass piles, twigs and branches or other garden debris to leaf piles as these items can damage equipment and prevent leaf collection.

Mayor Emanuel, Department Of Streets And Sanitation Announce New Dry Ice Pilot To Combat Rodents

Mayor Rahm Emanuel and the Chicago Department of Streets and Sanitation (DSS) today announced a new pilot program that uses dry ice to combat rodents. Crews will evaluate variables like storage and longevity, overall success rates and potential cost saving to determine whether the product could become a permanent tool for the Bureau of Rodent Control.

"This pilot program is one more way we are working to improve our neighborhoods and the quality of life for all Chicagoans," said Mayor Emanuel. "Investments in our city services are the cornerstones that help make our communities stronger and move the City of Chicago forward."

Crews wearing protective gloves place a spoonful of the dry ice directly into a rodent burrow and cover the hole. As the dry ice melts it turns into carbon dioxide, suffocating the rodents.

"We are continuously looking for new and innovate ways to provide the best service for the resident of Chicago," said DSS Commissioner Charles L. Williams. "Dry ice is an alternative that cities have been experimenting with and achieving tremendous success. And we are excited to evaluate its effectiveness here in Chicago to determine if it could be an added tool in our arsenal against rodents."

The Bureau of Rodent Control will continue testing the dry ice into late fall, weather

permitting, and conclude on the results in spring 2017. Preliminary results indicate a reduction of more than 60 percent after treating an area with dry ice.

The dry ice pilot is taking place at several park locations. Additional testing will also be conducted in planter boxes along Wabash, State, Chicago, Fairbanks and Superior.

This is the latest step in a series of enhancements DSS has undertaken to help combat rodents in Chicago.

In April, DSS redirected 10 crews to the Bureau of Rodent Control. The new crews have been able to complete approximately 41 percent more rodent abatement over last year; increase preventive re-baiting by 22 percent; and begin working toward the goal of ensuring all requests are addressed within five days of receipt

In 2016, the DSS continued enforcing the "Construction Site - Rodent Abatement Ordinance" that mandates a rodent abatement plan be maintained throughout the excavation process of any new construction within City limits.

Education remains a top priority. New informational posters are being placed at every baiting location to help residents understand how to eliminate food sources for rodents.

Skokie Fire Department Once Again Achieves Class 1 Rating

The Skokie Fire Department has once again achieved the prestigious Class 1 rating from the Insurance Services Office, Inc. (ISO), which is the highest achievable rating from ISO. Skokie first received this designation of exemplary public protection in 1995, and has retained the distinction in each subsequent ISO evaluation.

"The Skokie Fire Department is among the best in the nation," said Mayor George Van Dusen. "We are among the 57 fire departments in the country with the premier ISO Class 1 rating, and are one of only 26 agencies in the nation to also hold accreditation from the Commission on Fire Accreditation International. I am proud of the men and women of the Skokie Fire Department who serve our community day in and day out, ready to go into harm's way at a moment's notice to protect all of us, our homes and businesses."

ISO is the leading supplier of statistical, underwriting and actuarial information for the property/casualty insurance industry. The ISO review is conducted by highly qualified ISO staff on a five-year cycle and includes site visits, records examination and observation. The ISO team conducts a detailed evaluation of three main areas of fire protection capability and operations, including water

supply integrity and inspection processes, emergency communications and overall fire department operations.

"The ISO rating is the real measure of how the Skokie Fire Department provides emergency response to the community," said Fire Chief James Walters. "Our scores were near the top of the rating scales in all categories including response, equipment capability, dispatch services, personnel training, hydrant inspections and more. The detailed analysis ISO conducts is a true test of our department's dedication to best practices. I am proud that once again, the Skokie Fire Department is being recognized for providing the highest level of protection possible to the community we serve."

Most insurers use ISO and their Public Protection Classification for underwriting and calculating premiums for residential, commercial and industrial property insurance rates. Fire departments can receive any rating from 1, which is the best, through 10, which is the lowest. A fire department must meet ninety percent of the ISO standards to achieve or retain the Class 1 rating. The ISO team conducted the Skokie Fire Department's evaluation in April 2016, with the next ISO evaluation set to occur in four years.

FAiR Initiates Save Our Sleep (SOS) Campaign

The O'Hare "Fly Quiet" test phase is set to expire December 2016. Fly Quiet is a six-month test in collaboration with the Chicago Department of Aviation (CDA) and the Federal Aviation Administration (FAA) to make greater use of diagonal runways, shifting noise away from suburbs east and west of the airport and northwest side Chicago neighborhoods. Under the plan, runways (including diagonal runway 15 / 33) are rotated on a week-to-week basis for nighttime travel (10:30 p.m. to 5:30 a.m.). Fair Allocation in Runways (FAiR) contends that Fly Quiet in its current form should continue into 2017 with no interruption.

"Since early July, Fly Quiet has immediately reduced overnight noise exposure for the communities most severely impacted by the O'Hare Modernization Plan," noted Dan Dwyer, member of the FAiR leadership group. Complaints have skyrocketed in the last three years after the city shifted traffic from the older diagonal runways to new parallel east-west runways. This has significantly concentrated more traffic over the Northwest and North sides as well as the western suburbs. "Fly Quiet has, at the very

least, served to temper some of the residential anger fueled by overnight jet noise. Fly Quiet, under its current configuration, cannot be discontinued," stated Dwyer.

FAiR is proud to initiate the Save Our Sleep (SOS) campaign. In the coming weeks, FAiR will be pushing for the permanent institution of Fly Quiet. Further, FAiR will be asking our elected representatives, CDA, FAA and the O'Hare Noise Compatibility Commission (ONCC) to enact Fly Quiet as a mandatory (rather than voluntary) program and that it be extended into daytime operations during the weekends with permanent utilization of the 15 / 33 diagonal runway. "Fly Quiet has had a positive impact on quieting the overnight skies. Based on the low arrival and departure volumes for Saturdays and Sundays, there is no reason why these configurations cannot be extended to the weekends. If CDA Commissioner Ginger Evans is serious about 'pursuing ways to ensure that O'Hare remains a good neighbor to residents while retaining its status as the largest economic engine of the city of Chicago', then this would be a constructive start," noted John Kane, member of the FAiR leadership group.

City of Evanston Police and Fire Departments Provide 2016 Halloween Safety Tips

PARENTS

- Accompany young children while "Trick or Treating."

- Carry a flashlight, cell phone, and possibly a first aid kit.

- Plan a route with older children and agree on a time to "check in" with family.

- Never enter a person's home.

- Cross streets at intersections only.

- Do not allow your children to eat any candy unless checked by an adult first. Any unwrapped items should be discarded.

- Leave your pets at home. They may frighten easily and be more likely to bite.

- If your children are going to Halloween parties at others' homes, have them look for ways out of the home and plan how they would get out in an emergency.

- Tell children to stay away from open flames, including jack-o'-lanterns with candles in them. Be sure they know how to stop, drop and roll if their clothing catches fire. (Have them practice stopping immediately, dropping to the ground, covering their face with hands, and rolling over and over to put the flames out.)

COSTUMES

- Choose costumes that are bright and contain reflective material.

- Choose a costume without long trailing fabric, which could cause a child to trip or may touch flames in jack-o'-lanterns or other decorations.

- If you make your own costume, use materials that won't catch on fire easily if they come in contact with heat or flame.

- Carry a glow stick, glow necklace or flashlight to be more visible and to help see where you're going.

- Avoid costumes that cover a child's head and may prevent them from seeing a vehicle or other hazard. If your child is wearing a mask, make sure the eye holes are large enough so he or she can see out.

- Remember: Toy guns look real in the dark, so choose costumes that do not contain guns or weapons.

DECORATIONS & IN THE HOME

- Dried flowers, cornstalks and crepe paper catch fire easily. Keep all decora-

tions away from open flames and other heat sources like light bulbs and heaters.

- Use a battery-operated candle or glow-stick in jack-o'-lanterns. If you use a real candle, use extreme caution. Make sure children are watched at all times when candles are lit. When lighting candles inside jack-o'-lanterns, use long, fireplace-style matches or a utility lighter. Be sure to place lit pumpkins away from anything that can burn and far enough out of the way of trick-or-treaters, doorsteps, walkways and yards.

- Remember to keep exits clear of decorations so escape routes are not blocked.

- Make sure all smoke alarms in the home are working.

AROUND THE NEIGHBORHOOD

- Before you allow your child to knock on any door, become better informed. Check the Illinois Sex Offender Registry website at www.isp.state.il.us/sor. Learn who lives in the houses you plan to visit. Be cautious rather than sorry.

- Notify your Neighborhood Watch Groups of the "Trick-or-Treating" times, and have them walk the neighborhoods to look out for children and suspicious activity.

- Remind children to have respect for their neighborhood. Although these activities may seem like fun, smashing pumpkins, "egging," spray painting, and spraying property with shaving cream are all illegal activities that damage a person's property.

- Additionally, drinking alcohol in public and drinking under the age of 21 is against the law.

DRIVERS

- Children are excited and may be less cautious while walking. Drivers should be more cautious while traveling through residential streets.

- Before dusk and all evening, drive slowly and with your lights on in order to see children in costume.

- Don't drive distracted (cell phone/texting while driving).

Shore Adult Services Program finds new home in Skokie

September 27, 2016, Skokie, IL Years of uncertainty have finally ended for Shore Community Services.

In 2009 the nonprofit learned its long-term lease on the Lois Lloyd Center in Evanston, which housed its program for adults with moderate to severe and profound disabilities, was going to expire. They needed to relocate.

This was a major problem, as Shore relies completely on private donors for all non-operational funding. A new building would be expensive. Add in the constraints of location — the adult program serves people with disabilities in Skokie, Evanston and Morton Grove, so it couldn't venture too far — and Shore had a difficult task to achieve.

With some luck, and a great deal of hard work, Shore officials found the perfect home: an empty building at 8350 Laramie Avenue, Skokie — the former site of the Skokie Police Department. "At first I thought, 'Why would a police station be interesting to us?'" recalled Natalie Romano, President of the Shore Board of Directors. "But because it was a unique space, we realized we could utilize it for this program, and it had the administrative space that allowed us to sell our existing administrative building and use the proceeds to renovate the second floor."

Shore bought the former police headquarters in December 2014 and moved its administrative offices to the second floor that February. In December 2015, renovations began on the first floor. By July of this year, the Adult Services Program staff and clients were able to move in.

A quick walk around the premises will show any visitor the creativity Shore's staff and Architect Raffi Arzoumanian of Arzoumanian & co. had in redesigning the space. The entire first floor was gut-renovated to create nine group rooms, which each have a color-coded sign and a number to help Shore clients — most of whom cannot read — navigate the area. The Sally ports with garage doors were turned into glass windows and doors, and that area became a multi-purpose room. There is also an accessible kitchen, sensory room, nurse's office and gated garden area.

The new facility is the culmination of years of work by devoted staffers.

"It's a relief and it's almost — because it was such a struggle — it's hard to believe it happened," Romano said. "Construction moved according to plan, and once we got started everything fell into place. It's just surprising to look back and say 'Wow we did it.' That is a testament to the staff that did it."

Fulfilling a vision

In the late 1940s, Evanston residents Lois and Thomas Lloyd were told their daughter Patricia, who had severe disabilities, would have to live in an institution.

The Lloyds thought they could do better. They believed Patricia should have the same opportunities as anyone else her age, so they opened up the North Shore School for Retarded Children in the early 1950s. It would ultimately become Shore Community Services and serve thousands of people across the spectrum of intellectual and physical disabilities.

As society grew more accepting of people with special needs, so did the educational opportunities. It was no longer financially viable for Shore to operate its school, since children could get support from local schools.

But opportunities for adults with moderate to severe and profound disabilities were still few and far between.

Shore's Adult Services Program began in 1983, serving those adults who needed a middle ground between Shore's school and vocational services programs.

"For some of our clients we are a stepping stone for them to move on to the training center, but for the majority of our clients this is the most appropriate place," said Debbie Shulruf, director of the new Lois Lloyd Center.

More than 80 clients use the program, without which they might not have access to social events like the holiday parties, fashion shows and cooking classes that Shore puts on. Most of the clients cannot live by themselves — the majority live in Community Integrated Living Arrangements, or CILAs, staffed 24/7 with trained professionals. During the week they come to Shore to get training in prevocational job and adaptive daily living skills.

Keeping the Adult Program afloat means keeping the Lloyds' legacy alive, and Shore officials are more than happy to continue serving this vulnerable population.

"Certainly the whole planning process, to have it all come to fruition, is just a huge sigh of relief," said Mary Matz, Director of Development.

But such an impressive building inevitably comes with a cost. Shore is currently in the middle of a \$5 million capital campaign to cover the acquisition and renovation costs and build up its endowment. The new building will also need to be maintained and improved. The basement still needs renovating, Matz said. It could be turned into a space for social events if Shore meets its fundraising goals.

If Shore staffers have learned anything in this ordeal, it's that they remain steadfastly committed to their mission: serving adults with the greatest needs.

"We don't turn people away," Romano said. "We always want to be in a position where we can take on anyone."

Village Cooking Corner

Polish Kolackys

Ingredients

- 8 oz. cream cheese, softened
- 8 oz. (1 cup) unsalted butter, softened
- 11 1/4 oz (2 1/2 cups) unbleached all-purpose flour, sifted; plus more for rolling
- 1 12-oz. jar good-quality apricot preserves (about 3/4 cup) or any flavor fruit jam
- 1 large egg, beaten
- Confectioner's sugar, for dusting
- 1 Tablespoon Vanilla

In the bowl of a stand mixer fitted with the paddle attachment, beat the cream cheese and butter on medium-high speed until light and fluffy, about 3 minutes. Scrape down the bowl and paddle. With the mixer on low, gradually mix in the flour until a smooth dough forms.

Turn out onto a lightly floured surface and the dough gently to form a ball. Divide the dough in thirds, wrap each in plastic wrap, and flatten into squares. Refrigerate at least 4 hours or overnight. Heat the oven to 350 degrees F. Line 3 cookie sheets with parchment paper. Remove one piece of dough from the refrigerator and roll it out on a lightly floured surface into a 1/8-inch thick rectangle. Using a sharp knife or pizza cutter, trim the rough edges of the dough so the sides are straight, and then cut into 2 & 1/2 inch squares. Spoon about 1/2 teaspoon of the preserves onto the center of each square. Fold one corner into the center, dab with the beaten egg, and then bring the opposite corner into the center and pinch firmly together to seal the corners. With a thin spatula, transfer the cookie to the prepared cookie sheet. Repeat the process with the remaining dough.

Bake one sheet at a time until golden and very lightly browned and puffed, 10 to 12 minutes. Transfer to a rack to cool completely and then dust with confectioner's sugar.

You can freeze the fillings with little loss in flavor or consistency. As for the kolaczki. Freeze them filled and unbaked and bake them from the frozen state. Don't freeze baked kolaczki because when you defrost them, they will become soggy.


