



# Mayor Emanuel, Chicago Park District Celebrate Opening of Maggie Daley Park Skating ribbon, play garden, climbing features are now open to the public

Mayor Rahm Emanuel, Chicago Park District General Superintendent and CEO Michael Kelly, members of the Daley family and community leaders today cut the ribbon on the highly anticipated Maggie Daley Park in the heart of downtown Chicago.

"Children from neighborhoods across the City were touched by Maggie Daley through After School Matters and her love of the City; through this park, Maggie's legacy will continue to touch the lives of children from every corner of Chicago," said Mayor Emanuel. "This new jewel on Chicago's lakefront is just the latest example of the investments we're making in parks, playgrounds and recreational spaces in neighborhoods across the City to create a richer quality of life for all of our residents."

Maggie Daley Park will contribute unique new types of open space and activities to the programmatic range of Grant Park as a whole. The 20 acre park boasts signature elements like rock-climbing sculptures, an ice-skating ribbon and a three-acre play garden

"We are excited to bring such a unique experience to Chicago, as Maggie Daley Park is poised to become a new downtown destination for residents and visitors from near and far," said Superintendent Kelly. "Regardless of the season, this park provides an informal place for recreation and relaxation alongside a connective landscape that will broaden the appeal of Grant Park as a whole."

Nearly a quarter of a mile long and 20 feet wide, the J.B. and M.K. Pritzker Family Skating Ribbon provides 27,500 square feet of ice surface, which is nearly twice the size of a traditional skating rink. The ice ribbon can hold up to 700 skaters at a time. In the summertime, the ribbon can be used by roller-skaters and scooters or by gallery exhibitions and special events. Admission to the skating rink is free, and skate rental will be free on opening day. Going forward, skate rental will cost \$12.

The Malkin-Sacks Rock Climbing Wall's maximum height is approximately 40 feet over a total surface area of 19,000 square feet. The wall is divided into different sections for beginners and advanced climbers, accommodating bouldering, lead-harnessed and top rope climbing. Between 25 and 100

climbers can use the climbing wall at a time.

The southeast section of the park is anchored by a three-acre Play Garden, the first of its kind in Chicago. In the spirit of Alice in Wonderland and Charlie and the Chocolate Factory, play and plantings will have diverse opportunities for fun, adventure, exploration and learning for children of all ages. The Play Garden will create a one-of-a-kind play experience for children that captures their imagination, engages different senses in all seasons of the year and integrates the landscape with custom-designed play structures and sculptures. Up to 600 children can play in this feature at one time. The park also features the Blue Cross Blue Shield Great Lawn.

Maggie Daley Park is bordered by Columbus Drive, Randolph Street, Monroe Street and Lake Shore Drive. The \$60 million park was funded with \$40 million from the Chicago Park District and \$20 million in private donations.

In addition to the special features, the park will also include a variety of event spaces such as three large open lawn areas, a smaller lawn panel and café space. The park also will have picnic groves that can be used for smaller groups, such as birth-day parties. The remaining areas of Maggie Daley Park, including portions of the play garden, expanded landscape, and climbing walls, will be open to the public in Spring

Patrons can now register for winter programs at the renovated Maggie Daley Fieldhouse http://www.chicagoparkdistrict.com/. Winter programs begin January 5.

Under Mayor Emanuel's leadership, Chicago's park system has drastically expanded with the addition of nearly 1,000 acres of new park land, 27 new turf field, 17 new parks, 11 new community facilities, 150 refurbished playgrounds and more than \$500 million in capital investment from public and private sources. Earlier this year, the Park District won the 2014 National Gold Medal Award for Excellence in Park and Recreation Management. This is the first time Chicago or any urban park district has received this prestigious award.

# Winter Safety Tips for Families from the Nonprofit FLASH WW

According to the National Weather Service, extreme cold and winter storms in 2013 resulted in 46 deaths and extensive disruptions for thousands of families. With another cold blast this week, the nonprofit Federal Alliance for Safe Homes (FLASH) offers 21 winter safety and power outage tips to keep families safe and warm.

### Affordable Ways to Protect Your Home

For as little as \$1 per 6' of insulation, you can stop pipes from freezing during winter and even when the power goes out.

- 1. Insulate pipes exposed to the elements or cold drafts with insulating foam. For as little as \$1 per 6' of insulation, you can stop pipes from freezing and save energy.
- 2. Place an insulating dome or other covering on outdoor faucets and spigots to reduce the likelihood of the water in your pipes freezing, expanding and causing a costly leak
- 3. Drip faucets to reduce the build-up of pressure in the pipes. Even if the pipes freeze, you have released the pressure from the water system reducing the likelihood of a rupture. If you are going out of town, and suspect that temperatures will drop or a power outage will occur, turn off the water to

your home and open all of the taps to drain the water system. This way you won't return to a frozen, soggy mess.

4. Check for air leaks around windows and doors using a lit incense stick. If the smoke is sucked out of an opening, seal the leak with caulk, spray foam or weather stripping.

### **Keep Your Family Safe & Warm**

- 5. Keep a supply of flashlights, batteries and a battery-powered radio on hand. Do not use candles as they pose a fire hazard.
- 6. After the power goes out, make sure to turn off all lights but one, to alert you when power resumes.
- 7. Resist the temptation to call 911 for information during power outages. Instead use your battery-powered radio for information.
- 8. Keep your car fuel tank at least half full as gas stations rely on electricity to operate their pumps and may not have back-up power.
- 9. Keep extra cash on hand since an extended power outage may prevent you from withdrawing money from ATMs or banks.
- 10. Be a snow angel. Volunteer to check on elderly neighbors, friends, or relatives who may need assistance during the outage.

11. Wear layers of loose fitting, light-weight, warm clothing rather than one layer of heavy clothing. The outer garments should be tightly woven and water repellent. Never burn charcoal for heating or cooking indoors

12. If you are using a gas heater or fireplace to stay warm, be sure the area is properly ventilated.

13. Arrange ahead of time with family, friends, or neighbors for a place to go if you have an extended outage. If you have nowhere to go, head to a designated public shelter. Text SHELTER + your ZIP code to 43362 (4FEMA) to find the nearest shelter in your area (example: shelter 12345)

### Food

14. Keep a supply of non-perishable foods, medicine, baby supplies, and pet food on hand, and have at least one gallon of water per person per day on hand.

15. Avoid opening the fridge or freezer. Food should be safe as long as the outage lasts no more than four hours.

### Generators

16. Do not run a generator inside a home or garage. Use gas-powered generators only

in well-ventilated areas.

- 17. Follow manufacturer's instructions such as only connect individual appliances to portable generators.
- 18. Don't plug emergency generators into electric outlets or hook them directly to your home's electrical system as they can feed electricity back into the power lines, putting you and line workers in danger.
- 19. Consider purchasing and installing a permanent home generator with an automatic on switch.

### **When Power Returns**

20. When power comes back on, it may come back with momentary "surges" or "spikes" that can damage equipment such as computers and motors in appliances like the air conditioner, refrigerator, washer or furnace. Be sure to install a system of surge protection that consists of point-of-use devices and whole house surge protection.

21. When power is restored, wait a few minutes before turning on major appliances to help eliminate potential problems caused from sharp increases in demand.

# **Car Prep for Cold Weather Ahead**

- Test your battery Have it checked out, as your battery can lose power due to the drop in temperature. The last thing you want is to be stuck in freezing weather with a car that won't start!
- Check your tire pressure monthly For every 10 degrees the temperature drops, your tires can lose about 1 pound per square inch (PSI) of pressure. Monitor your tire pressure more closely during the winter time.
- Replace all-season tires with winter tires Temperatures lower than 45 degrees cause your all-season tires to stiffen and lose traction, but the latest generations of winter tires remain flexible in freezing temperatures, improving traction and available grip. Check your tire depth with the penny test to make sure you have enough tread to grip the road in ice and precipitation.
- Keep your car washed Keep the exterior washed and waxed to protect your vehicle from the elements as the seasons change.

# FEMA Winter Tips - Stay Safe During Bitterly Cold Temperatures and Dangerous Snow Conditions

Dangerously low temperatures and accumulating snow are in the forecast for much of the Midwest and the U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA) wants individuals and families to be safe when faced with the hazards of cold temperatures and winter weather.

"Subfreezing temperatures and wind chills can be dangerous and even life-threatening for people who don't take the proper precautions," said Andrew Velasquez III, FEMA Regional Administrator. "It is important for everyone to monitor their local weather reports and take steps now to stay safe, whether traveling or at home, during times of extreme cold temperatures."

During cold weather, you should take the following precautions:

- Stay indoors as much as possible and limit your exposure to the cold;
- Dress in layers and keep dry;
- Check on family, friends, and neighbors who are at risk and may need additional assistance;
- Know the symptoms of cold-related health issues such as frostbite and hypothermia and seek medical attention if health conditions are severe.
- Bring your pets indoors or ensure they have a warm shelter area with unfrozen water.
- Make sure your vehicle has an emergency kit that includes an ice scraper, blanket and flashlight – and keep the fuel tank above half full.
- If you are told to stay off the roads, stay home. If you must drive, don't travel alone; keep others informed of your schedule and stay on main roads.

# State of Illinois 2015 Future City® Competition— Students Developing Concepts for Feeding Future Cities

As part of the 2015 National Future City® Competition, over 40 middle school teams from the local area will be competing with designing a city with its own food resources under the concept of "Feeding Future Cities." This is the largest number of teams registered in the 22nd year of the Illinois competition. The State of Illinois Regional competition is currently preparing for the sixth, seventh and eighth graders to compete on Jan. 24, 2015. The Illinois regional committee is currently working with the teams, professionals who serve as team mentors to work with students, and judges for the upcoming competition. The public can attend the competition for free which will be held at the University of Illinois at Chicago.

During the Future City® Competition, students worked as a team to design a virtual city and solutions using SimCity™ software. Over the past four months, the students researched the defined city wide issue and write an essay with their findings and solutions. The team builds a tabletop scale model of their city using recycled materials with a budget no greater than \$100 and they write a brief narrative promoting their city. All teams have the same budget and have access to the software.

On Jan. 24, 2015, student teams will present their version of the future to a panel of judges at the Regional Competition held at the University of Illinois at Chicago. After the judging, awards will be presented in the afternoon. The public is invited to attend the competition and show for free.

"This is the 22nd year of conducting this regional competition. This year's competition requires students to create a vision for the future regarding "Feeding Future Cites." It is an interesting topic and more critical as the world's population continues to grow," said Future City® Competition Regional Coordinator Don Wittmer, P.E., Transportation Manager with HNTB.

The winning team from the Illinois region will receive a fully paid round-trip, travel and hotel accommodations, to compete in the National Finals held in Washington, DC on Feb. 22-28, 2015 during National Engineers Week. The four-day national competition will result in one team receiving the top national prize of a trip to U.S. Space Camp for one week stay in Huntsville, AL and \$7,500 for organization's STEM(Science, Technology, Engineering, and Mathematics) program.

"The Regional Competition brings together innovative students from Chicago and throughout Illinois. We are always surprised by their creativity and excitement," stated Matthew A. Miller, P.E. with HNTB. The top teams from the region share their transformative ideas at the Annual Chicago Engineers Benefit on Feb. 27, 2015.

# Local Author Stan "Tex" Banash To Discuss Roadside History Of Illinois At Norwood Park Senior Center Jan. 26

Chicago author Stan "Tex" Banash will discuss his third book, Roadside History of Illinois, at the Norwood Park Senior Center, 5801 N. Natoma, in Chicago, at 4:00 p.m., on January 26. A cowboy style dinner will follow the event, and a \$5.00 per person donation is requested. Copies of the book will be available for purchase and inscription following the talk.

If you are interested in learning about some lesser known facts related to Illinois history and be introduced to the places and events where history happened, this is a power-point presentation you won't want to miss. Banash, who serves as director of public relations at Norwood Crossing, a long-term care retirement community in Norwood Park, will present a brief overview of the book, explain some of the state's history



from the Ice Age to the present, and point out a few of the significant incidents in the state's seven regions that helped shape the state. The book takes readers along old U.S. highways, state roadways and county roads, leading to the people, places and events that contributed to the state's development. It is the first book on Illinois history in more than 30 years and has been praised by former U.S. Sen. Adlai E. Stevenson III and Wayne C. Temple, Chief Deputy Director of the Illinois State Archives.

Last May, the Illinois House of Representatives recognized the importance of the book to Illinois history by passing a House Resolution that congratulated the author on its publication.

Active in his local community, Banash is a six-term past president of a local chamber of commerce and chaired a local zoning advisory board for 19 years. He also operated his own home-based public relations firm for more than 30 years. The author graduated from Northwestern University with a Bachelor of Arts degree in Political Science and obtained a Master of Arts degree in Urban Studies from Roosevelt University. His two earlier books were Best of Dee Brown's West and Dee Brown's Civil War Anthology. He also reviews books for a number of western publications, and is a member of Western Writers of America, the Society of Midland Authors, Illinois State Historical Society, Western History Association, and the Westerners—Chicago Corral, where he served as its sheriff for five years.




# **Skokie Idol Begins January 31**

# Local Artist Tests the Limits of Painting Haberman Exhibit Part of Broader Campaign to Revitalize Northwest Side Arts Scene

The work of painter and Northwest Side resident Jared Haberman will fill the walls of the Perkolator coffeehouse January 5 through February 14. The exhibit will be presented in conjunction with the Northwest Arts Connection, a grassroots organization dedicated to highlighting the area's cultural opportunities and talents.

Haberman is best known for painting intense colors, on repurposed vintage windows. Other work incorporates ripped pieces of paper from newspaper comics, old prayer booklets, music sheets and even old phone books. Each piece challenges audiences to think beyond the norm and realize that practically anything can serve as a painter's canvas, including book pages, windows or plexiglass.

For Haberman, the unconventional use of materials was an early trademark. "I always carried a sketchbook on me and a Precision tipped black pen to sketch with," he said, reflecting on a childhood obsession. "I filled books and books full of sometimes the same drawing over and over again, front to back, both sides of the paper. I would frequently run out of paper and have to use the back of an old poster, or in my most recent ventures, phone book pages, and now, onto windows."

The Haberman exhibit will be one of many planned collaborations between the Northwest Arts Connection and Perkolator, which opened last fall in the heart of Portage Park's Irving-Austin business district at 6032 W. Irving Park Road.



While many small business owners wouldn't think of spending hundreds of thousands of dollars on a new house and then leaving the front door unlocked while they are out of town, that is essentially what they do when it comes to their valuable intangible business assets. However, this important business necessity is often forgotten or ignored (or, more recently, put to the side because of financial limitations) and businesses often inadvertently leave their valuable intellectual property "unlocked" and open to use or theft by third parties by their failure to acquire adequate protection.

While the new house example in the previous paragraph is presented tonguein-cheek, it serves to illustrate the importance of protecting the intellectual property associated with one's business. The statement is often made, "I was always told that I didn't need federal registrations in order to protect my intellectual property." While it is true that a trademark owner can establish some rights based on legitimate use in commerce, owning a federal trademark registration on the Principal Register of the United States Patent and Trademark Office provides several advantages, including: (1) constructive notice to the public of the registrant's claim of ownership of the mark; (2) a legal presumption of the registrant's ownership of the mark and the registrant's exclusive right to use the mark nationwide on or in connection with the goods and/or services listed in the registration; (3) the ability to bring an action concerning the mark in federal court; (4) the use of the U.S registration as a basis to obtain registration in foreign countries; and (5) the ability to file the U.S. registration with the U.S. Customs Service to prevent importation of infringing foreign goods. Similarly, federal copyright registrations (as opposed to common law or "poor man's" rights) provide for a number of benefits in addition to having one's rights a matter of public record- especially in the event of a third party infringement. In particular, registered copyrighted works may be eligible for statutory damages (e.g., plaintiffs who can show willful infringement may be entitled to damages up to \$150,000 per work) and attorney's fees in successful litigation—and I promise you that attorney's fees are a big deal in a federal litigation under even the best of circumstances.

Finally, it is important to remember that registered trademarks and copyrights are identifiable and quantifiable assets that increase the overall valuation (and potential revenue-generating opportunities) of a business.

# Illinois Dept. of Revenue Tax Change Halves Taxes on Vehicle Leases

Thanks to a new Illinois law that takes effect Jan. 1, 2015, state taxes on vehicle leases will be reduced by as much as 50 percent, allowing consumers to get more car for less money. House Bill 2317, signed by Gov. Quinn in May 2014, alters the way taxes are collected on light-vehicle leases. Prior to Jan. 1, a leasing customer paid tax on the entire purchase price of the vehicle. After Jan. 1, customers intending to lease a new vehicle will pay taxes only on money due at lease inception and monthly lease payments. Because most vehicles have a residual value of 50 percent or more, this change reduces the taxes owed by new lessees by 50 percent or more.

Nationally, the number of new-vehicle owners that are leasing has grown to 26 percent – a figure that has doubled over the last five years. Illinois has lagged well behind at just 14 percent. Leasing rates in Chicago are among the lowest for any metro market in the United States. By comparison, New York metro has a lease rate of 50 percent and Cleveland, 48 percent. The change in the way vehicle leases are taxed in Illinois should make leasing a much more attractive option for new-car shoppers.

"The Chicago metro market has never had good lease penetration because of the way the state taxed vehicle leases," said Colin Wickstrom, Chicago Auto Trade Association (CATA) chairman. "With this change in the tax law customers will be able to afford more car than ever – perhaps lowering their monthly payments at the same time."

Prior to Jan. 1, a DuPage County resident leasing a \$27,000 vehicle for 36 months with no money down would expect to pay about \$1,890 in state taxes. After Jan.1, that same customer would pay just \$945 in taxes – assuming the vehicle had a residual value of 50 percent. That's a savings of \$945, amounting to more than \$25 per month. The savings get even greater on 24-month leases or more expensive vehicles. For example, a DuPage County resident leasing a \$60,000 vehicle for 24 months with a 65-percent residual prior to Jan. 1 would pay \$4,200. After Jan.1, that same customer would pay \$1,470 in taxes, saving \$2,730 in taxes over two years.

While many assume new vehicle leasing is reserved just for luxury brands, a list of the top 10 models leased in the United States renders that assertion false. According to Experian Information Solutions\*, each of the top 10 lease vehicles has a starting M.S.R.P below than \$25,000. In addition, compared to buying, leasing can lower the monthly payment by \$100 or more.

The Illinois new-car dealers accounted for \$28.4 billion in total retail sales in 2013 – 15 percent of the state's total.

"The CATA, along with the Illinois Auto Dealers Association, worked to show the Illinois Department of Revenue that changing the way the state collects tax on vehicle leases would not only be good for the consumer, but would result in more revenue for the state," said Dave Sloan, CATA president.

Starting on Jan. 1, the CATA will launch a million-dollar educational campaign branded "The Lease You Can Do: More Car, Less Money." The multifaceted print, broadcast and online effort is designed to help Chicago area buyers understand why vehicle leasing makes financial sense and how the leasing tax law changes will help them lower monthly payments or afford a more expensive vehicle.

# **Complete Asset List is Essential**

A complete list of your assets is the essential starting point in making any decisions about those assets, whether financial portfolio decisions or estate planning decisions.

Without a complete list of your financial assets, a financial planner cannot know how to change your assets to achieve the proper asset allocation to meet your risk, return, and diversification objectives.

Without a complete list of all of your assets, your estate planning attorney cannot advise you with regard to taxation issues. Further, without beneficiary designation and titling information, the estate planning attorney cannot be sure your wishes will be carried out.

Even valuable personal property, such as jewelry, rare coins, etc., should be itemized by you. Ideally, such items should be photographed as well. This list can serve many purposes. If you have a fire, burglary, or other issues arise, this list and the accompanying photographs can help you file a claim with the insurance company.

Do not forget items in safe deposit boxes or other little-accessed areas. First, having a list of such assets will be helpful in the event that there is delay in finding a key. At least your family will know the contents and the urgency, if any, of gaining entry to the box. Also, while extremely unlikely, safe deposit boxes have had their contents looted or destroyed. For example, Singapore-based DBS Bank's Hong Kong branch recently destroyed 83 safe deposit boxes. Evidently, the bank was renovating the vault and some active boxes were accidentally removed and destroyed. The bank offered an unquestioned settlement of approximately \$20,000 per box. Anyone claiming more would have to provide an itemized list of the items in the box.

Of course, when choosing items to place in the safe deposit box, leave out items you may need in an emergency, such as originals of your property power of attorney, health care power of attorney, living will, and, in many states, your will.

A complete list of assets is essential for financial and estate planning. Any financial or estate plan is like a map that takes you from point A to point B. Unfortunately, if you don't know where point A is, it's impossible to give directions from there to point B. The more thorough your list of assets, the better advice professionals can give you.



Now if you are planning to retire in the New Year, or maybe file for Medicare during the general enrollment period, you may be thinking that is another trip. And you thought after the holiday season you could take it easy. When it comes to taking care of Social Security business, it is easy. You'll find that www.socialsecurity. gov makes it easy to stay home and get that one last thing done. You can check off much of your Social Security business quickly and securely from your home using your computer or tablet (which you might have unwrapped early). At the Social Security website you can-

- Create a my Social Security account, which enables you to:
- obtain an instant, personalized estimate of your future Social Security benefits:
- verify the accuracy of your earnings record—your future benefit amounts are based on your earnings record, so it is important to make sure your earnings are recorded properly;

Keep in mind that the New Year brings planning for tax season, and your wait time may be longer if you call or visit a local Social Security office. Generally, you'll have a shorter wait time if you call during the week after Tuesday. Trees should be removed from any bags when placing them in the tree recycling corrals.

"Recycling your Christmas tree is not the only way Chicagoans can be green this season," said DSS Commissioner Charles L. Williams. "Residents have many options for reducing their impact on our environment from recycling cardboard gift boxes in their Blue Carts to saving wrapping pa-

per and bows for next year."

Additionally, select recycling locations will have free mulch available for residents to pick-up beginning on Tuesday, January 6.

"We're excited to provide Chicagoans an opportunity to help protect the environment by recycling their live Christmas trees this holiday season and in return provide free mulch to our residents starting January 6, when available at select locations," said Michael P. Kelly, General Superintendent and CEO of the Chicago Park District.

# Village Cooking Corner

# Hungarian Chicken Paprikash

On Easter Sunday last year our family was gathered at my younger brother's house to celebrate and share a great meal and desserts. I was surprised when two of my nieces asked me for the recipe for Hungarian Chicken Paprikash. I assured them that I would give it to them. Sometime later I looked in three Hungarian cook books which I have in English, as well as in two more in German, and each one was different! It was very frustrating, and that is why I didn't give the recipe to the young ladies until Thanksgiving, along with a container of authentic "Szeged" Hungarian Paprika. Here is how I learned it from my mother:

Ingredients: Whole chicken, cut up; or chicken legs, or chicken tenders avail-able at Aldi & other stores. Sweet Hungarian paprika (Szeged) or sharp if you so desire. Onion, garlic, sour cream, flour, water, and salt to

Procedure: If you have a whole chicken, cut it up into pieces or use chicken legs, cut in half. Remove excess fatty skin, but leave on some of the less fatty skin. Anytime you use meat with bones in it, it will give you a more hearty flavor. Use a bit of olive or vegetable oil and brown the chicken on both sides, then set aside. Chop the onion & brown in same pan. When nicely browned, add the chopped garlic and paprika and stir constantly for about a min-

ute. Use about 1-1/2 tsp. paprika. I suggest you measure it & then record how it turned out. If you're not sure, use less rather than more because you can always add some. Add about one cup of water (or enough to cover the meat) and stir. You can always add more if needed. Add the chicken pieces and salt lightly. Cover the pot and simmer until the chicken is tender, turning the meat over at least once. To finish the dish, use about 2 tablespoons of sour cream, which you have taken out of refrigerator so that it at room temperature, and stir in about the same amount of flour with only enough water so it is the consistency of gravy. Use your judgment, depending on how much gravy you need for the amount of chicken you have. When chicken is done, push pieces to one side & slowly add the sour cream mixture, stirring constantly. Keep the heat low and allow to thicken. Mix together with the chicken and keep stirring and then taste the sauce. Serve with homemade or bought spaetzle or pasta of your choice, cooked "al dente." Or, you can add peeled potatoes when the chicken is simmering. Test for doneness. Serve with a vegetable or salad of your choice. Good luck & enjoy!
