


Sids Awareness Month And Higher Birthrates = Higher Demand For Milk

October is SIDS Awareness Month, a time we focus on preventing infant mortality as best we can. According to the Centers for Disease Control and Prevention, for every 1,000 babies born, six die during their first year.

The Milk Bank, based in Indianapolis, is passionate about helping prevent infant mortality through the use of human break milk. They pasteurize and distribute human milk donations to babies in need throughout the Midwest, especially during this time of year—August through October—when we see the highest amount births. With depot locations in five different states, they provide services that help prevent infant loss and facilitate bereavement milk donation. They recently had a donor that kept pumping six months after her baby was born so she could donate her milk to help infants in need.

Bereavement donor Sheri Rukavina said, "Donating filled my heart with such excitement and joy because I knew I was helping these fragile little preemies in honor of my sweet son."

Drug Collection & Disposal Program For Village of Skokie

Prescription drug abuse has reached epidemic proportions. Most abused prescription drugs come from family and friends. Additionally, drugs that are flushed down the drain or disposed in the garbage find their way into waterways, contaminate surface waters and harm the environment.

To prevent prescription drug abuse and help the environment, the Village of Skokie has a Drug Collection and Disposal Program. There is a white drop-off box in the lobby of the Skokie Police Department, 7300 Niles Center Road, for residents to dispose unwanted, unused and expired medication at any time. This location offers 24-hour secure monitoring, collection and subsequent disposal in accordance with federal regulations. This site also accepts narcotics and other controlled substances. The program, which began in 2012, has collected over 3,265 lbs to date.

Accepted drugs include prescription medications, controlled substances, all over-the-counter medications (i.e. pain relievers, cold medication, etc.), medication samples, pet medications, vitamins and supplements, medicated ointments, lotions, creams and oils, liquid medication in leak-proof containers and homeopathic remedies. This program does not accept needles/sharps, syringes with needles, thermometers, IV bags, bloody or infectious waste, personal care products, empty containers and hydrogen peroxide.

The Skokie Health Department, 5127 Oakton Street, also accepts medications and used syringes/needles in puncture-proof containers. The Skokie Health Department drop-off convenience is available from 8:30 a.m. to 5 p.m. Monday through Friday. The Skokie Health Department is unable to accept controlled substances and non-prescription liquids.

Mayor Rahm Emanuel, CDA Announce New Runway And South Air Traffic Control Tower At O'Hare International Airport

New 7,500 foot runway on O'Hare's south airfield will substantially improve capacity and efficiency

Mayor Rahm Emanuel and the Chicago Department of Aviation (CDA) announced today the opening of new Runway 10R-28L and a new South Air Traffic Control Tower (SATCT) at O'Hare International Airport. Runway 10R-28L is an East-West parallel runway located on the south airfield. It will be used primarily as an arrival runway and will substantially improve O'Hare's capacity and efficiency.

"When we invest in O'Hare's future, we are helping Chicago continue to grow economically and compete on a global scale," Mayor Emanuel said. "The new runway will reduce delays and increase airport capacity - a positive development for travelers and businesses who rely on O'Hare. And while O'Hare may be the busiest airport in the world, our goal is to make it the best airport in the world. With the help of this new runway and our other investments, we are on track to achieving that goal."

"Modernizing our airfield and improving capacity at the world's busiest airport is critical to addressing many important challenges such as reducing delays, mitigating noise and improving the customer experience," said CDA Commissioner Ginger S. Evans. "I want to thank the Federal Aviation Administration, our airline partners and Mayor Emanuel for their commitment to seeing this project through, and their continued support of future airport improvements."

"The new runway at O'Hare is another milestone for the airport and the entire city of Chicago," said Alderman Michael Zalewski, Chairman of Committee on Aviation. "O'Hare elevates Chicago's standing on the world stage, and it attracts companies to Chicago as well as jobs to our neighborhoods. This is a positive step in the right direction, but we know that there is more work ahead for the airport, our city, and its residents."

Runway 10R-28L is the fifth East-West parallel runway at O'Hare and the fourth new runway component opened since 2008 as part of the O'Hare Modernization Program (OMP). The runway is 7,500 feet in length and 150 feet in width and includes a 7,500-foot-long East-West parallel taxiway (Taxiway W) immediately north of the runway and a 2,000-foot-long connecting taxiway to the south airfield (Taxiway AA). Construction on the \$516 million runway and taxiway system began in spring 2011.

"As Chicago's hometown airline, we are committed to a strong and vibrant O'Hare that can compete with leading airports throughout the world," said Tracy Lee, vice president of network operations at United Airlines. "This runway will make O'Hare even more efficient, enhancing the travel experience for our customers and ensuring the airport remains a premier global hub."

"On behalf of the more than 100,000 American Airlines employees worldwide and especially the 9,000 here in Chicago, I'd like to commend all those involved in the conception, development and construction of the new runway," said Michael Minerva, Vice President Government and Airport Affairs for American Airlines. "As the largest airline in the world, Chicago is a key hub in our network and we look forward to growing here in the near future."

The new runway will significantly improve O'Hare's East flow arrival and departure rates in all weather conditions, which will increase throughput and reduce delays. More specifically, the benefits of Runway 10R-28L during East flow operations include:

• 24 percent increase in airport arrival rates (114 flights per hour versus 92 flights per hour) during good weather (VFR) conditions.

• 25 percent increase in airport departure rates (110 flights per hour versus 88 flights per hour) during good weather (VFR) conditions.

• 40 percent increase in airport arrival rates (106 flights per hour versus 76 flights per hour) during poor weather (IFR) conditions.

• 18 percent increase in airport departure rates (90 flights per hour versus 76 flights per hour) during poor weather (IFR) conditions.

A new \$41 million FAA air traffic control tower was built to manage aircraft operations Runway 10R-28L. The new tower is 218-feet-tall (13 levels) with a 10,000 square-foot base building. It was designed to achieve LEED Gold certification by the U.S. Green Building Council and includes a 10,000 square-foot vegetated green roof, a geothermal energy system, and many other sustainable features. The commissioning of Runway 10R-28L and the SATCT marks the completion of all south airfield construction on the OMP.

No state or local taxpayer dollars were used to fund these projects.

Elected Officials Stand with FAiR--More Noise and Pollution and No Relief to Citizens NOT a Reason to Celebrate New Runway Opening

The Fair Allocation in Runways (FAiR) Coalition is pleased that a number of elected officials have decided to decline today's opening of the new southern runway 10R/28L and instead stand with residents who have been barraged with constant levels of jet noise and pollution since the October 2013 runway opening and flight pattern changes at O'Hare. "We are glad and proud that many of our elected partners recognize that until meaningful changes are made to fairly allocate air traffic around the entire airport--north and south, east and west, day and night--a new runway bringing more noise and pollution to new communities and to those already suffering from the 2013 changes is nothing to celebrate," said FAiR Leadership Team member Colleen Mulcrone.

Earlier this week FAiR members and supporters called on elected officials to boycott the opening of the new runway. "FAiR thanks our elected officials for staying home and continuing to advocate for the people on the ground in their communities," said Linda Waltz, FAiR Leader. State Senator John Mulroe (10th), State Representative Christine Winger (45th), Schiller Park Mayor Barbara Piltaver, Wood Dale Mayor Nunzio Pulice, Park Ridge acting Mayor Marty Maloney and Alderman Marc Mazzuca (6th), and Bensenville Village Trustee Henry Wesseler all declined the invitation to attend the runway opening and stand on the side of citizens. Added Mulcrone, "These officials get it--the lived experiences of the real people under those planes day in and day out must be addressed and improved. The governor gets it--he signed the law that provides a solution: permitting the diagonal runways to remain. We are waiting for Mayor Emanuel to get it--and have the will and courage to fix it."

Family Dynamics on Display in The Lion in Winter

As we approach the holidays, we are reminded of the importance of families. Each winter we gather together to perform yearly rituals, share a meal or two, and give gifts of appreciation to the most important people in our lives. All of the bickering that take place during the rest of the year becomes unimportant, because after all, what family doesn't have its ups and downs.

This is the main theme of James Goldman's award winning play The Lion in Winter, which will be performed at Skokie Theatre from November 6 - 22. Part fam-

ily comedy, part historical drama, this unique play takes Kings and Queens from the 12th century and paints them as a modern day family. Aging King Henry II must choose an heir to the throne from among his three sons. He favors his youngest while his strong-willed wife, Queen Eleanor of Aquitaine, favors their eldest. Sparks fly as they try to out-maneuver each other in this wickedly clever story.

King Henry is the "man of the house" with his wife Eleanor, who is every bit as capable and refuses to be just a housewife living in a man's world. Their eldest son Richard is the best and the brightest, and the family sports hero (if you count the crusades as a sport). Young John is the baby of the family, and is handed everything the other children had to work for. And Geoffrey is invisible to his parents in that special way that only a middle-child can be. The play takes place at Christmas, which wasn't actually celebrated in 1183, but what better setting is there to put these dysfunctional family dynamics on display. As they bicker over who takes over which parts of the family business, audiences see themselves and their families in the squabbles, and that what makes it so entertaining.

I appeared in the play for the first time when I was just a teenager. I played the youngest son, Prince John. Although I doubt that I solved any personal issues with my father and my brother through the experience, I at least enjoyed working through the situation in the context of the play. In fact, almost every actor I know has wanted to perform this play at some point for the same reason.

Now that I'm old, I get to move into the role of family patriarch. And although I had no sympathy for Henry in my youth, becoming an adult and raising my own child has put his story in a whole new light for me. And just to keep me in line, my real-life wife Debra Criche Mell joins me on stage as Queen Eleanor. We met performing on stage together 30 years ago, but have rarely appeared together since. This royal family reunion serves as a personal reunion for us as well.

The Lion in Winter performs from November 6 – 22, Fridays and Saturdays at 7:30 pm, Sundays at 2:00 pm, and on Wednesday November 11 at 1:30 pm. Tickets are \$34 general admission, \$29 for seniors, and \$24 for students. It's not too late to sign up for a three-show subscription packeage, which will include tickets for the romantic comedy Beau Jest in February, and the powerful Prime of Miss Jean Brodie in April / May. City Announces Opportunities For The 2016 Riverwalk Concession Program

City Seeking a Mix of Recreational, Cultural, Entertainment, Food, Beverage and Retail Opportunities; Proposals are Due Dec. 2

Building upon the success of 2015, the City has issued a Notice of Availability (NOA) today for concession operations for the Chicago Riverwalk's 2016 season. The goal of the NOA is to allow vendors an opportunity to submit proposals which will continue to activate and draw visitors to the Riverwalk. The City envisions a mix of recreational, cultural, entertainment, food and beverage and retail facilities on the Riverwalk, creating a vibrant area to be enjoyed by residents, tourists and visitors alike. Based upon the positive reaction by Chicago's residents and visitors throughout the summer, the City expects to receive a large number of highly competitive proposals for the 2016 season.

"So many residents and families came together and enjoyed the Riverwalk this season," said Mayor Rahm Emanuel. "We anticipate another season of exciting cultural, entertainment, food, and beverage and retail choices for residents and visitors to relax, have lunch or dinner and enjoy the next great recreational frontier of our great city in 2016."

This past season, visitors to the Riverwalk were able to enjoy a tiki bar, wine bars, Belguim beer and frites, and recreational options included bike rentals to kayak tours. The late addition of the Hideout midway through the season provided a unique experience for Riverwalk patrons to relax and enjoy live music in an urban canyon of significant architecture. Throughout the summer, huge crowds visited the Riverwalk and on high volume days some Riverwalk restaurants reported 45 minutes waits for tables and many of the paddling excursions and bike tours were sold to capacity.

The City is now seeking vendors to provide a variety of activities, events, and services in 2016. Examples of possible concessions include, but are not limited to: facilities for human-powered boating; bike rentals; other sports rentals; food and beverage; retail, particularly of a cultural or environmental nature; educational facilities: entertainment venues: commercial boats docked along the seawall with food and beverage or associated with a food and beverage provider operating in the land adjacent; or any other type of family-friendly concessions. The Department encourages Respondents to propose other ideas to enhance the use and enjoyment of the Riverwalk and the Chicago River. One year contracts will be awarded with the possibility of a one year extension.

Proposals are due by noon on Wednesday, December 2, 2015 and will be reviewed by an Evaluation Committee. The Evaluation Committee is comprised of city personnel familiar with the Riverwalk. The Evaluation Committee will score each proposal based upon the following criteria:

- Green-Sustainable Plan
- Compensation to the City of Chicago
- Projected Annual Sales
- Financial Capacity

Vendors interested in participating in the 2016 Season on the Chicago Riverwalk are invited to attend a Pre-Proposal Meeting on November 4, 2015 at 2:00 p.m. in Room 1103 in City Hall, 121 North LaSalle Street. City representatives will describe the program and answer questions during the pre-proposal meeting. The City also strongly encourages Respondents to visit the Riverwalk prior to attending the Pre-Proposal conference.

Vendors unable to attend the Pre-Proposal Meeting can submit questions to ChicagoRiverwalk@cityofchicago. org with "Notice of Availability Spec# 135525" as the subject. The deadline for questions is 4:00 p.m. on November 6, 2015. Questions will be responded to in an Addendum to the Notice of Availability.

The existing Riverwalk vendors are wrapping up the 2015 Season on Sunday, November 1. The Riverwalk will remain open to the public to use the seating, the pedestrian path and enjoy the views between 6 a.m. - 11 p.m. each day.

In May of 2015, three new blocks of the Riverwalk; the Marina, the Cove and the River Theater, extending the pedestrian trail along the Main Branch of the Chicago River beyond State Street to LaSalle Street. During the 2015 Season, the Riverwalk hosted multiple vendors providing food and beverage and a variety of recreational options.

Much of the Riverwalk is complete; Phase 3, the City's final phase of construction, will extend the Riverwalk from the west side of LaSalle Street to the north side of Lake Street by the fall of 2016. The Notice of Availability is for the section between LaSalle Street to Lake Shore Drive.



20 Moments: Chicago in the 20th Century

Tuesday, October 27 6:00 p.m.

What is Chicago? What will Chicago be in the future? What has Chicago been in the recent past? These are all complex questions that fascinate Chicagoans, whether they have been here five months or fifty years. Drawing on historic photographs and visual materials from the Chicago Public Library, the Chicago History Museum, and other institutions, urbanologist Max Grinnell will invite patrons into a discussion of these themes via a presentation with time for conversation and discussion afterwards

This program is part of the 2015-2016 One Book, One Chicago season, exploring the theme of "Chicago: The City That Gives.

Armenian Dedication Event

On Sunday October 25, 2015, St. James Armenian Church in downtown Evanston will unveil the installation of a traditional khachkar (literally cross (khach) stone (kar). His Eminence Khajag Barsamian, Archbishop of the Eastern Diocese of the Armenian Church of America, will consecrate this uniquely Armenian monument in honor of the canonization of the over 1.5 million martyrs of the Armenian Genocide of 1915, which occurred earlier this year. The consecration ceremony will take place at the conclusion of the special episcopal Divine Liturgy (mass), which begins at 10AM.

The khachkar monument, standing over ten feet tall in St. James' front garden, was carved out of tuff

stone in Armenia this summer and then shipped to Evanston. The art of carving khachkars dates back to the 4th Century and today, among other things, symbolizes the rebirth of Armenian culture after centuries of hardship. Though there are thousands of khachkars around the world, no two khachkars are alike. St. James' khachkar was commissioned by the parish and paid for through donations by dozens of individuals and families in the community in the name of loved ones both living and deceased.

The St. James parish will also mark the occasion by celebrating its 70th Anniversary as a testimony to Armenians' presence in the greater Chicago community.

REGINA STEAM LAB INCLUDES 3D PRINTER AND ROBOTS

Regina Dominican students were introduced to a new STEAM lab when they returned to school this year.

The STEAM (Science, Technology, Engineering, Arts, and Math) lab is a continuation of Regina Dominican's Vision 2020 initiative. One component of this initiative takes a look at ways the faculty and staff canimplement project-based learning into the school's strong academic curriculum. The STEAM lab has two initial components: a STEAM robotics club and a 3D printer.

Law Does Not Provide for a Social Security Cost-of-Living Adjustment for 2016

With consumer prices down over the past year, monthly Social Security and Supplemental Security Income (SSI) benefits for nearly 65 million Americans will not automatically increase in 2016.

The Social Security Act provides for an automatic increase in Social Security and SSI benefits if there is an increase in inflation as measured by the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W). The period of consideration includes the third quarter of the last year a cost-of-living adjustment (COLA) was made to the third quarter of the current year. As determined by the Bureau of Labor Statistics, there was no increase in the CPI-W from the third quarter of 2014 to the third quarter of 2015. Therefore, under existing law, there can be no COLA in 2016.

Other adjustments that would normally take effect based on changes in the national average wage index also will not take effect in January 2016. Since there is no COLA, the statute also prohibits a change in the maximum amount of earnings subject to the Social Security tax, as well as the retirement earnings test exempt amounts. These amounts will remain unchanged in 2016. The attached fact sheet provides more information on 2016 Social Security and SSI changes.

The Department of Health and Human Services has not yet announced Medicare premium changes for 2016. Should there be an increase in the Medicare Part B premium, the law contains a "hold harmless" provision that protects approximately 70 percent of Social Security beneficiaries from paying a higher Part B premium, in order to avoid reducing their net Social Security benefit. Those not protected include higher income beneficiaries subject to an income-adjusted Part B premium and beneficiaries newly entitled to Part B in 2016. In addition, beneficiaries who have their Medicare Part B premiums paid by state medical assistance programs will see no change in their Social Security benefit. The state will be required to pay any Medicare Part B premium increase.

Mayor Emanuel Announces 10 Additional Crews Are Being Redirected To Forestry To Completely Eliminate Tree Trimming Backlog

Mayor Rahm Emanuel today announced that the Department of Streets and Sanitation (DSS) is redirecting 10 crews to the Bureau of Forestry to completely eliminate the backlog in tree trimming requests.

This investment is made possible by \$9.5 million in operational savings achieved through grid refuse collection, which reduced the average daily deployment of garbage trucks from 310 to 292.

"The proper maintenance of Chicago's parkway trees is an important investment in our neighborhoods," said Mayor Emanuel. "By expanding the resources available to the Bureau of Forestry, the City is protecting the health and vibrancy of the urban canopy for years to come and helping to make sure requests for tree trims are answered as quickly as possible for residents."

This announcement builds on Mayor Emanuel's previous efforts to improve tree trimming services for residents. In 2015, the Mayor made a \$700,000 budget investment for 2015 weekend forestry work, which has helped eliminate the tree trimming backlog by 50 percent.

In October 2014, the DSS had 28,000 open tree trimming requests dating back to 2012. To date, there are approximately 14,000 open requests that were submitted within the 2015 calendar vear.

"The Department of Streets and Sanitation is constantly working to improve response time and productivity in tree trimming. The additional resources for 2016 are a smart investment in the proper care of Chicago's growing urban canopy, as well as an important step to completely eliminating the City's tree trim backlog,' said Commissioner Charles L. Williams.


