Throughout November, the Library offers a variety of programs highlighting the history, culture, traditions, and contributions Native Americans have made to Chicago, the state of Illinois, and to the U.S. In addition, a selected bibliography and the Library's 2015 Native American Heritage Month Calendar of Events are available at chipublib.org.

The opening program for Native American Heritage Month takes place on Saturday, November 7, at 11:00 a.m., at the Edgewater Branch, 6000 N. Broadway St. Debbie Reese, author, lecturer, and blogger will be the keynote speaker. Ms. Reese is tribally enrolled at Nambe Pueblo and has a PhD in Education from the University of Illinois and an MLIS from San Jose State University. ## American Writers Museum Announces Prime Michigan Avenue Space In Downtown Chicago For Early 2017 Opening

#### Central Location Grants Visitors And Locals Easy Access To First Museum In United States Dedicated To American Writers, Past And Present

The American Writers Museum (AWM) has leased a prime space at 180 North Michigan Avenue, one of Chicago's busiest blocks, for its early 2017 opening.

The location's proximity to hotels, residential buildings, universities, cultural attractions, Millennium Park, and public transportation provides a vibrant home for the first and only museum to engage the public in celebrating American writers and their influence on our history, our identity, our culture, and our daily lives.

Showcasing the personal stories and literary works of diverse American writers, from Mark Twain to Dr. Seuss, the interactive, high-tech museum is expected to draw up to 120,000 visitors annually. The museum's esteemed curating team and National Advisory Council are working closely with internationally renowned museum and exhibit companies in the museum's development. AWM is also collaborating with 50 authors' homes and museums around the U.S. – now AWM Affiliates

#### Mayor Emanuel Opens Newcity Development In Lincoln Park Major Retail, Entertainment And Residential Project Creating Hundreds Of Jobs

Mayor Rahm Emanuel today cut the ribbon to open the NewCity development in Lincoln Park. The 8.5-acre "neighborhood within a neighborhood" combines retail, dining, entertainment, residential living and medical office space. The recently-completed \$265 million project began construction in December 2013 and employed more than 1,000 construction workers. The development will employ approximately 500 full-time and 700 part-time workers.

"From residential to retail, NewCity is bringing new opportunities and creating hundreds of jobs for Chicagoans," said Mayor Emanuel. "This project is a great example of how we can work together to reinvent and redefine communities to build a better Chicago for all."

"The NewCity development is creating good jobs and driving economic development throughout the area," said Alderman Walter Burnett Jr. "The 27th ward is a great place to live, work, and do business – and thanks to this development it is getting even better."

NewCity's 360,000-square-feet of retail space features a Mariano's Grocery and a number of entertainment and restaurant concepts. Additionally, the site features a one-acre land-scaped plaza; pedestrian-friendly sidewalks, 1,000-space public parking garage, and valet service. The 200 rental unit residential tower has 16 levels and the project includes more than 30,000-square-feet of medical office space.

"NewCity is creating hundreds of jobs and will serve as a major economic driver for the area," said John Bucksbaum, CEO of Bucksbaum Retail Properties LLC. "We are excited to open this new retail, residential and entertainment option for the people of Chicago."

#### "Fall Back" While Stepping Up Your Disaster Readiness

Sunday, November 1, Daylight Saving Time ends and we set our clocks back an hour. Take advantage of extra sleep, then take a few simple steps to make your home more disaster-resilient:

Verify your carbon monoxide and smoke detector work. Follow the manufacturer's instructions for testing the equipment to ensure it's functioning appropriately. Invest in new detectors if they're near or past the manufacturer's recommended replacement age.

Have a professional inspect the chimney and any fuel-burning heating equipment (fireplaces, furnaces, water heaters, wood stoves, coal stoves, space heaters and portable heaters) in your home to verify everything is working properly. If you're using a fireplace, space heater or wood stove, make sure that anything flammable is at least three feet away. Space heaters are particularly dangerous if used improperly. Make sure to use heaters that have the label of a recognized testing laboratory and always operate according to the manufacturer's guidelines.

Winterize your home to extend the life of your fuel supply by insulating walls and attics, caulking and weather-stripping doors and windows, and installing storm windows or covering windows with plastic. Insulating pipes will help prevent them from freezing.



#### **Cook County Working To Bring Western Access To O'Hare International Airport** First Formal Agreement Approved By Board Of Commissioners

Cook County has officially joined to drive to bring much-needed western access to O'Hare International Airport

The Elgin O'Hare Western Access (EOWA) project, which carries a current price tag of \$3.4 billion, will allow travelers and commercial shipping and freight services to access the airport from the western suburbs. The project will also enhance access to major commercial and industrial centers in the northwest suburbs as well as remedy traffic congestion on I-294 and at interchanges on I-290 and I-90.

On Wednesday, the Cook County Board of Commissioners approved an intergovernmental agreement (IGA) with the Village of Itasca, the Illinois State Toll Highway Authority, the Illinois Department of Transportation and DuPage County for construction of EOWA. While the IGA is the first formal multi-governmental agreement for the EOWA, Cook County and its partners have been working together on the innovative transportation project since 2012.

The EOWA has the potential to transform the economy of communities surrounding the airport

while also benefiting motorists and air travelers, said Cook County Board President Toni Preckwinkle. "Transportation projects in this region need to be coordinated on a regional level," Preckwinkle

said. "When I took office, I transformed Cook County's former Highway Department into a Department of Transportation so that when projects like this are being planned, we can play a major role in ensuring that regional projects serve multi-modal transportation needs.'

Cook County has already invested Motor Fuel Tax funds toward the EOWA project. Early construction has begun and the entire project is expected to be completed by 2023.

President Preckwinkle said she is grateful to DuPage County Chairman Dan Cronin for offering to work in collaboration with the Cook County Department of Transportation and Highways.

The Tollway Authority will design and construct the Elgin O'Hare Expressway, extending it from its eastern terminus at Rohlwing Road (Illinois Route 53) to O'Hare International Airport. The project will also connect the Jane Addams Memorial Tollway (I-90) with the Tri-State Tollway (I-294).

Since 2011 Commissioner Walsh has worked as head of Business Development at Mark J. Walsh & Company, a Chicago based commodity trading advisor.



### Helping Veterans And Active Duty Military Members

On Veterans Day, the nation honors the men and women who risk their lives to protect our freedom. Social Security honors veterans and active duty members of the military every day by giving them the respect they deserve. A vital part of that is administering the Social Security disability program.

For those who return home with injuries, Social Security is a resource they can turn to. If you know any wounded veterans, please let them know about Social Security's Wounded Warriors website. You can find it at www.socialsecurity.gov/woundedwarriors.

The Wounded Warriors website answers many commonly asked questions, and shares other useful information about disability benefits, including how veterans can receive expedited processing of disability claims. Benefits available through Social Security are different than those from the Department of Veterans Affairs and require a separate application.

The expedited process is used for military service members who become disabled while on active military service on or after October 1, 2001, regardless of where the disability occurs.

Even active duty military who continue to receive pay while in a hospital or on medical leave should consider applying for disability benefits if they're unable to work due to a disabling condition. Active duty status and receipt of military pay doesn't necessarily prevent payment of Social Security disability benefits. Although a person can't receive Social Security disability benefits while engaging in substantial work for pay or profit, receipt of military payments should never stop someone from applying for disability benefits from Social Security.

### **Remembering the Meaning of Veteran's Day**

Red, white, and blue circulars announcing 50% off all mattresses. No school! The gas station's flag flying at half mast. For too many of us, these are our Veteran's Day associations. For those of us not directly impacted by the war in Iraq, for those without friends and family who have served, it is far too easy to forget the meaning of this important day.

Veteran's Day began as Armistice Day to commemorate the end of World War I – optimistically coined "the war to end all wars." President Woodrow Wilson declared, "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice..."

Though the War did not officially end until June 28, 1919, an informal armistice was signed at the 11th hour on the 11th day of the 11th month of the preceding year. For this reason, Veteran's Day falls on November 11. This was not always the case. Attempts were made to change the date so it would fall on Monday, making for convenient three-day weekends. Recognizing that this was not a holiday about a get-away to the Dells or shopping sprees at the mattress store, and realizing the significance of this important historic commemoration, President Gerald Ford responded to the American people and returned the holiday to November 11.

Most of us do not like war. But, we must separate those feelings from the gratitude we owe to those who have served. It is important that we take pause from our busy lives and imagine a day in the life of those in service – sleepless nights, grueling work, physical hardship, separation from loved ones, fear, and loss. It is important that we take a moment to thank the men and women who have made supreme sacrifices for our country. Come Wednesday, November 11, bake cookies for your local VFW; ask a veteran to share his or her remembrances of service; send a care package to our troops; gaze at the gas station's flag at half mast and remember exactly what that means.

#### Family Dynamics on Display in The Lion in Winter

As we approach the holidays, we are reminded of the importance of families. Each winter we gather together to perform yearly rituals, share a meal or two, and give gifts of appreciation to the most important people in our lives. All of the bickering that take place during the rest of the year becomes unimportant, because after all, what family doesn't have its ups and downs.

This is the main theme of James Goldman's award winning play The Lion in Winter, which will be performed at Skokie Theatre from November 6 - 22. Part family comedy, part historical drama, this

unique play takes Kings and Queens from the 12th century and paints them as a modern day family. Aging King Henry II must choose an heir to the throne from among his three sons. He favors his youngest while his strong-willed wife, Queen Eleanor of Aquitaine, favors their eldest. Sparks fly as they try to out-maneuver each other in this wickedly clever story.

King Henry is the "man of the house" with his wife Eleanor, who is every bit as capable and refuses to be just a housewife living in a man's world. Their eldest son Richard is the best and the brightest, and the family sports hero (if you count the crusades as a sport). Young John is the baby of the family, and is handed everything the other children had to work for. And Geoffrey is invisible to his parents in that special way that only a middle-child can be. The play takes place at Christmas, which wasn't actually celebrated in 1183, but what better setting is there to put these dysfunctional family dynamics on display. As they bicker over who takes over which parts of the family business, audiences see themselves and their families in the squabbles, and that what makes it so entertaining.

I appeared in the play for the first time when I was just a teenager. I played the youngest son, Prince John. Although I doubt that I solved any personal issues with my father and my brother through the experience, I at least enjoyed working through the situation in the context of the play. In fact, almost every actor I know has wanted to perform this play at some point for the same reason.

Now that I'm old, I get to move into the role of family patriarch. And although I had no sympathy for Henry in my youth, becoming an adult and raising my own child has put his story in a whole new light for me. And just to keep me in line, my real-life wife Debra Criche Mell joins me on stage as Queen Eleanor. We met performing on stage together 30 years ago, but have rarely appeared together since. This royal family reunion serves as a personal reunion for us as well.

The Lion in Winter performs from November 6 - 22, Fridays and Saturdays at 7:30 pm, Sundays at 2:00 pm, and on Wednesday November 11 at 1:30 pm. ## Yard Gear Readying for Winter Storage

Set up a safe work zone. Identify a safe location with plenty of work space that is out of the way of children and pets. Work only in a well-ventilated area that is away from heat sources, sparks or flames

Collect your outdoor power equipment. This might include a lawn mower, generator, string trimmer, chain saw, edger, power washer, blower, chipper, splitter, or other tool that uses a small engine to do outdoor work

Turn equipment off. Before servicing or repairing any outdoor power equipment, disconnect the spark plug and battery cables.

Protect yourself. Wear safety glasses and gloves to protect against harmful chemicals and debris.


Inspect your outdoor power equipment. Make sure safety guards are not disabled or missing. Check for loose belts or missing or damaged guards. Check and tighten all screws and nuts.

Clean your equipment. Grass, leaves and dirt that have accumulated on equipment should be removed. Use a soft rag or cloth to clean away grime and dirt.

Drain the fuel. Stored equipment should not have fuel in its tank. Many fuels today contain ethanol, which absorbs water and may phase separate, causing operating problems. If there is fuel in the tank, remove what remains. Run the engine until the engine stops so the fuel is used up. Get more information on safe fueling at www.LookBeforeYouPump.com

Store leftover fuel properly. Gasoline should be stored no more than 30 days without being treated with a fuel stabilizer. Use a sealed container that is approved for fuel storage. Always keep fuel out of the reach of children and away from heat sources or flames

Lubricate, sharpen, and charge as needed. Check the oil levels and blade conditions. Change the oil now if needed. Get lawn mower blades sharpened so it will be ready for spring. Inspect the spark plug, replace it, and add clean engine oil. Check the air filter and clean or replace as needed. If equipment has a removable battery, take it out and store it in a warm spot. If you have a battery charger, charge the battery before storing it. Service equipment. If you are not comfortable performing some of these tasks or think that your equipment needs additional servicing, now is a good time to take it to a dealer or repair shop. Identify and clear a safe storage space. An indoor storage area will protect equipment from the elements. Your storage area should be cool and dry, and equipment should be out of the reach of children and pets. Store equipment away from pool chemicals, cleaners, or fertilizers-anything that could cause corrosion from spills. Properly store supplies. Using approved storage containers for lawn care or yard supplies will help avoid spills in storage spaces. Leftover materials should be stored in sealed containers, so pests like rodents are not drawn to them. Keep containers out of the reach of children and pets. Locate your winter outdoor power equipment. Locate snow shovels, snow blowers or throwers, ice scrapers, ice melt or rock salt. If you are low on winter supplies, now is a good time to stock up. Place winter equipment and supplies in an accessible location so they can be found easily when the first snowflakes and ice arrive.

#### What to ask when adopting a shelter dog

October is national Adopt A Shelter Dog month, and doctors from BluePearl Veterinary Partners are offering tips to prospective pet parents as they take the big step of adding another member to the family.

Thousands of lovable dogs in shelters are eagerly waiting families to give them forever homes. But that does not mean every dog is a good fit. So adopting families should ask as many questions as possible about a shelter dog's history, said Dr. Jill Sackman of BluePearl of Veterinary Partners.

And don't stop there. It's just as important to ask some questions of yourself, Sackman said. Sackman is a BluePearl clinician who offers behavioral counseling and serves as senior medical director of BluePearl's Michigan hospitals. She also is in charge of the behavioral medicine service. She offered these tips for families getting ready to adopt their new best friend from a shelter:

#### Ask if the shelter has done a behavioral assessment of the dog.

It's standard procedure at many shelters, and can give you valuable insight into whether a certain dog is right for you, and whether you are right for that dog.

#### Ask for as much information as possible about the dog's history.

Dogs grow up to be less anxious if they are exposed to a wide range of new and pleasant experiences before the age of 16 weeks, the puppy's socialization window. Less anxious, less fearful dogs are not nearly as likely to become aggressive as adults. Your shelter dog will likely be older than 16 weeks, and this is one reason you want to learn about the dog's background.

Sackman said, "You have to ask the question, what's my home like? How will my other pets respond? What are my needs? What's my time investment? Prepare a list of questions about a potential pet. And then ask a lot of good questions about the dog's history. Why was he surrendered? Was he found as a stray? Was he surrendered from another shelter? Any information that you have can help you better understand how well that animal will fit into your house."

#### Ask if you can spend a little time with the dog in the shelter

Especially in a quiet setting, away from a noisy kennel. If the dog is friendly and playful, that's a great sign. If the dog is standoffish and nervous, that's something to take into consideration. But remember that even wonderful shelters can be stressful environments for dogs. A dog's behavior can change after getting to your home.

#### Consider your own family's ability to care for a dog.

If you have small children, it might not be the best time to adopt a dog who tends to be nervous, aggressive or needs a lot of time-consuming training. On the other hand, if you're single with time to devote to training, this might be a challenge you can take on.

#### Prepare your family for their new dog.

Children, with their rapid movement, high-pitched voices and a tendency to jab fingers anywhere, can be alarming to some dogs. This can sometimes cause dogs to become anxious and snap. So involve your children in the care of your dog – such as helping with the food or water, or having the kids train the dog in basic tasks such as sitting or lying down. But also teach children when to back off – not to hug dogs while they're eating, for example.

#### Give the pooch a little space.

"After bringing your dog home, you might keep them in a laundry room or a confined kitchen and not immediately throw them in with all your other pets, if you have other pets. Establish relationships and give them and other pets some time to acclimate," Sackman said.

#### What if in spite of everything, my dog acts aggressively to family members or neighbors?

Seek help from your family veterinarian, or a veterinarian who is trained in behavioral medi-

#### Joint Tenancy, a Will or a Trust? What's the Best Way to Plan Your Estate?

Only the woefully uninformed believe that Intestate Probate, also known as "the government's estate plan for you if you don't have your own," is preferable to creating your own estate plan.

The problem is that newspapers, magazines, and other media often present conflicting views on whether it is best to choose joint tenancy, a will or a trust as your estate planning vehicle. Who's telling the truth?

Let's take a look at the three fundamental goals of an effective estate plan:

• Transferring your property to those you designate in a timely and efficient fashion,

• Providing for management of your property if you are physically or mentally unable to do so yourself, and

• Minimizing the amount of estate taxes imposed by the government as your property passes to succeeding generations.

Now that you know what an estate plan is supposed to accomplish, you can see how the "Big Three" estate planning vehicles stack up. Joint Tenancy is frequently thought of as a "poor man's will" because the asset transfers automatically upon death to the people named on the title.

What this technique offers in convenience it loses in protection. Consider the case of Dorothy Schmit vs. the Internal Revenue Service. Mrs. Schmit put her husband, who happened to be delinquent in his taxes, on "her" property as a joint tenant for convenience. Mrs. Schmit had to sue all the way to the 9th Circuit Court of Appeals, an expensive proposition, to get the IRS to finally accept the "nominal" status of her husband.

#### Scams Aimed At Veterans, Caregivers And Donors Cheat And Dishonor Vets Service

The Better Business Bureau (BBB) is warning veterans and their families of scams that may be targeting them. The scams also target those with plans to donate to a military or veteran- related cause. The BBB says veterans and civilians who are planning to donate to a charity for Veteran's day should use caution; and recommends that they research the organization and check with the BBB.

"While these types of scams represent the most common there can also be several variations of them," says Steve J. Bernas, president & CEO of Better Business Bureau serving Chicago and Northern Illinois. "It's important to remember, never give money to someone online or over the phone when you aren't 100 percent certain where it's going or what your donation will be used towards."

The most common veteran scams include:

• Charging veterans for services they could get for free or less expensively elsewhere, such as military records.

• Fraudulent investment schemes that convince veterans to transfer their assets into an irrevocable trust.

• Offering "instant approval" military loans ("no credit check," "all grades and ranks approved") that can have high interest rates and hidden fees.

• Advertising housing online with military discounts and incentives then cheating service personnel out of the security deposit.

• Trying to sell things like security systems to spouses of deployed military personnel by saying the service member ordered it to protect his or her family.

• Selling stolen vehicles at low prices by claiming to be soldiers who need to sell fast because they've been deployed.

• Posing as government contractors recruiting veterans and then asking for a copy of the job applicants' passport (that contains important personal information).

• Posing for online dating services as a lonely service member in a remote part of Iraq or Afghanistan, and then asking for money to be wired to a third party for some emergency.

If you plan on donating to a military-affiliated charity this year, here are some tips on how to avoid scams:

• Watch out for charities that sound similar to more well-known ones. Many fake veterans' charities include the same words in different order or form to appear legitimate.

• Look for a clear description of the organization's programs in its appeals and on its website. If the charity says it's helping veterans, does it explain how (financial assistance, shelter, counseling) and where it is doing so?

• Telemarketing can be a costly method of fundraising unless carefully managed. If called, do not hesitate to ask for written information on the charity and its finances before making a decision.

• Be wary of excessive pressure in fundraising. Don't be pressured to make an immediate on-the-spot donation. Legitimate charities will welcome your gift whenever you want to send it.

• If donating clothing or other goods, find out how the charity benefits from the collection and re-sale of gifts.

• Check first before giving for free with charity monitoring services like BBB's give.org.

Both wills and living trusts are more sophisticated ways of transferring property to your heirs. The primary difference between wills and trusts is that wills require a probate administration that can add time and costs to the disposition of your estate. Handling property management with a living trust can be of great help because many financial institutions and insurance companies are hesitant to accept durable powers of attorney, but are comfortable with successor trustee management.



In summary, the living trust's avoidance of probate and the protection of the successor trustee in the case of incapacity are strong reasons to consider a trust-based estate plan. **Chester M. Przybylo**

### Cook County Less Real Estate Translates Into Real Savings for Cook County

Less Real Estate Translates Into Real Savings for Cook County Taxpayers

Oak Forest Health Center campus reduction, warehouse consolidatioamong strategies designed to trim County's property footprint

Cook County Board President Toni Preckwinkle today announced real estate consolidation and realignment initiatives that are expected to reduce County building square footage by the equivalent of 4.5 football fields in 2016, with estimated annual operating savings of more than \$1.3 million and avoidance of over \$30 million in immediate capital investment.

Early in her first term, President Preckwinkle issued an executive order to re-evaluate and devise a strategic multi-year plan to address the County's real estate infrastructure. As a result, the Cook County's Real Estate Asset Strategic Realignment Plan project was initiated to review the condition and use of the County's real estate assets. Its recommendations, if fully implemented, are expected to save the County \$192 Million over a 10-year period.

"Cook County occupies too much space and has historically used it inefficiently," Preckwinkle said. "I have repeatedly said we will do whatever we can do make government more efficient and fiscally responsible, and reducing our real estate footprint is a good example of that. These actions will save money and streamline County operations."

The Oak Forest campus contains 1.1 million square feet of building area, with the Oak Forest Health Center and Cook County Health and Hospitals System administrative space as the primary occupants. The County estimates roughly 50 percent of the campus is underused or used as inactive storage areas.

Over the next 20 years, it would cost the County an estimated \$350 million to operate the campus. With some of the buildings on campus dating back to 1910, the County also estimates the campus would need roughly \$130 million in capital investment over that time frame.

With a long-range goal of consolidating uses on the campus to less than 300,000 square feet, the County intends to demolish seven buildings in the coming year, reducing the Oak Forest Health Center campus by almost 260,000 square feet, or about 23 percent of its current size. This will avoid 10-year capital investment of more than \$100 million on functionally obsolete buildings, and reduce operating expenses by roughly \$1.3 million per year. Health care services would be relocated in buildings designed to enhance the delivery of care and reduce costs.

Since taking office, President Preckwinkle has overseen the County's leasing of the 4th, 34th and 35th floors at the George W. Dunne Administrative Building, with an increase in annual revenues from the building averaging \$2 million.

President Preckwinkle has reiterated her commitment to further shrink the County's facilities footprint and to lease excess space in its 69 West Washington building. The County has set a target of leasing an additional 75,000 square feet by 2018 at 69 West Washington as part of its ongoing initiative to reduce the real estate footprint of county government.

The County saved \$10 million by purchasing a new Records Center for storage of court documents. The building more efficiently uses space for its designated purpose and reduced the square footage occupied by these records. In 2016, plans will be finalized to further consolidate from the County's two general warehouses to one, shrinking occupancy by more than 400,000 square feet by 2018.

"This is an important step toward better utilizing our real estate during challenging financial times," President Preckwinkle added. "By modernizing our approach on real estate, we can reduce office space and reduce costs. Over the coming months, we will be pushing a comprehensive plan to further increase efficiency and reduce our use of real estate to address our fiscal challenges."

## Village Cooking Corner

### **BAKED COD FISH ALA KALAMATA** (BAKALIARO PLAKI)

This is a recipe that was handed down to me by our mother who came from the area of Kalamata the capital of Messinia in the southern tip of the Peloponnese in Greece. It is a favorite in homes throughout Greece and the United States.

4 to 6 filets of fresh cod	1 finely sliced onion
2 garlic cloves, mashed	1/2 cup extra virgin olive oil
Juice of 1 lemon	1 cup water
1/2 cup currants, or raisins soaked in 1 cup of white wine	
1 (16 oz) can whole tomatoes chopped	Several whole cloves
2 Tbsp. chopped parsley	Salt and pepper to taste

This recipe is better if you are able to purchase (dry cod fish - bakaliaro<sup>\*</sup>) rather than fresh cod. But either will work fine. Assuming you purchase dry cod fish, place in water so that you can get rid of the heavy salt. Keep in water for a full day and change the water frequently. Rinse and saute in hot oil until slightly browned. If you use fresh cod, you will not need to saute, but the flavor of the dry cod fish is really extraordinary.

Place the cod filets in a greased baking pan. Sprinkle each steak with salt and pepper; rub with garlic and pour lemon juice over the fish. Lightly, saute in olive oil the onions, parsley and the tomatoes. Add the currants or raisins, wine, cloves and 1 cup of water. Simmer about 5 minutes. Pour this sauce over the fish and bake at 400 degree F for about 45 minutes to an hour. Baste the fish several times as it is baking. You may have to add just a little more water as it bakes.

This is great served with green vegetables e.g., Dandelion greens or Endive, seasoned with salt extra virgin olive oil and lemon juice and a crusty Greek bread for dunking the delicious sauce.
