

Chicago Area Peace Corps Celebrates 50th Anniversary with Tree Dedication

This year marks the 50th anniversary of the Peace Corps. Communities across the nation are commemorating the legacy of the more than 200,000 American Peace Corps volunteers who have served around the world since 1961 promoting global peace, friendship and understanding on behalf of the United States through an exchange of skills and culture.

On a local level, the Chicago Area Peace Corps Association (CAPCA) and the Chicago Regional Peace Corps Office are coordinating an outdoor tree and plaque dedication ceremony on Monday, August 29, at 1 p.m. in Federal Plaza, at Dearborn and Adams in Chicago. The chosen event date marks when the first group of Americans departed for Peace Corps service on Aug. 29, 1961. A team of 51 volunteers arrived in Accra, Ghana, on Aug. 30 to begin their teaching assignments as part of this bold new international outreach program.

Since that time, some 5,300 Chicagoland residents have served in Peace Corps, and approximately 300 local volunteers from the area are serving at any given time. The dedication event will highlight the work of Peace Corps volunteers overseas and here at home, and recognize our volunteers from five decades of service. The event is free and open to the public. Attendees will include a wide range of returned Peace Corps volunteers, as well as consulate offices and local officials, including 32nd Ward Alderman Scott Waguespack who served as a Peace Corps volunteer in Kenya and will emcee the event. Juliet Sorensen will be a guest speaker. Ms. Sorensen served as a Peace Corps volunteer in Morocco, 1995 to 1997, and is the daughter of Ted Sorensen, notable aide and speechwriter to President John F. Kennedy. She is now an assistant professor at Northwestern University School of Law Center for International Human Rights and served as Assistant U.S. Attorney in Chicago.

"Peace Corps volunteers are integrated in all facets of our community, including running our non-profits, teaching in our schools, holding public office, operating our businesses and more – all with the added advantage of understanding the greater world beyond U.S. borders," says Kathy Kacen, who volunteered in Armenia 2002-2005 and is now president of the Chicago Area Peace Corps Association, a non-profit organization of more than 300 returned Peace Corps volunteers who live and work in the Chicago area with a focus on community service, cultural education and exchange, and continued support for overseas Peace Corps volunteer projects. "As Peace Corps volunteers having lived two years in a developing country, we bring a passion for service and humanity back home with us, along with a better understanding of global issues and whole host of new skills."

The Peace Corps traces its roots and mission to 1960, when then-Sen. John F. Kennedy challenged students at the University of Michigan to serve their country in the cause of peace by living and working in developing countries. From that inspiration grew a federal agency devoted to world peace and friendship.

Throughout its history, the Peace Corps has adapted and responded to the issues of the times. From HIV/AIDS education to emerging technologies to environmental preservation to new market economies, Peace Corps volunteers have helped people build better lives for themselves. Their work in villages, towns, and cities around the globe represents a legacy of service that has become a significant part of America's history and positive image abroad. Today, some 8,655 volunteers are working with local communities in 76 countries in areas including education, health, environment, agriculture, youth and community development, and business and IT. By living and working in their global communities, Peace Corps volunteers also build cultural bridges and dispel stereotypes.

The Peace Corps Regional Recruitment Office in Chicago covers an 11-state territory and nominates the most volunteers to the Peace Corps annually. "Peace Corps service offers a unique combination of international experience, rewarding work and service to one's country," says Katie O'Connor, manager of the Chicago Regional Recruitment Office and Chicago native who served as an environment education volunteer in Nicaragua. "It changed my perspective of the world and allowed me to grow personally. Professionally, it fosters ability to adapt, problem-solve and work across cultures, which are important skills for our future leaders."

College Illinois! Recovery Taskforce Holds Hearing

The College Illinois Recovery Taskforce held a public hearing Thursday to provide an open forum for the discussion of the recent media driven investigation into the investment practices of College Illinois!, the State's prepaid 529-college tuition program.

State Representative Michael McAuliffe (R-Chicago) serves as a member of the taskforce and was at the hearing today to ask questions for his constituents.

"I've received several calls from constituents concerned about their investment in College Illinois! They want to know what is wrong with the program and what should they do to protect their investment," said Rep. McAuliffe. "I joined the taskforce to try to get answers for them and to do whatever I can to turn the program around."

The taskforce invited the new Illinois Student Assistance Commission Chair Kym Hubbard, professional investors, university officials, and families who hold contracts in the program to testify on what they believe needs to be done to help College Illinois!

Rep. McAuliffe asked Hubbard if she could guarantee that the fund would be available for those contract holders that plan to send their children to college in five years. Hubbard said at this point she could not answer because that would be speculative. "Over the next few months we are going to look at many different ideas and solutions as a taskforce to try to get College Illinois! back to being a safe and confident investment for Illinois families," said McAuliffe.

The taskforce, comprised of 21 legislators and headed by State Rep. Jim Durkin (R- Western Springs), will focus on stabilizing the funding of the program while providing an opportunity for the public to join the discussion.

Currently, approximately 35,000 families across the State of Illinois hold College Illinois! contracts.

NILES NORTH OPENS 2011-12 THEATER SEASON WITH "GOD OF CARNAGE"



General Friedrich Wilhelm Von Steuben German-American Hero

General Friedrich Wilhelm Ludolf Gerhard Augustin Von Steuben was born in Magdeburg, Germany on September 17, 1730. Von Steuben's military career began at an early age, when he entered the Prussian army and served with Distinction in the Seven Year's War. He later became the aid of Frederick the Great of Prussia, who was recognized as the military genius of his time. Von Steuben became expert in the drilling and training of troops. Because of this exceptional ability, Benjamin Franklin and Count St. Germain, French Minister of War persuaded Von Steuben to volunteer his military expertise to the American Revolutionists.

Von Steuben sailed for America and arrived at Portsmouth, NH in 1778 to aid the young nation in its fight for independence. He offered his services to General Washington without rank or pay, arriving at Valley Forge in the late winter of 1777-78. He found the soldiers in deplorable condition, without uniforms, weapons or

food. Appointed by Congress to be inspector General of the Army, Von Steuben set about training the unorganized band of ragged soldiers. He infused in them a sense of discipline and converted them into an excellent fighting force, training them to bear arms, march, form columns and to execute maneuvers with precision. He gave confidence to the officers and men, enabling them to continue on to victory at Yorktown.

As "Drill Instructor" of the Continental Army, Von Steuben wrote "Regulations of the Order and Discipline of the Troops of the United States." Although his Manual has been modified, it still remains in the basic guide for the discipline and drill of the Army.

On June 28, 1778, Von Steuben's training was put to test when the American troops encountered the British

Army near Monmouth Courthouse in the town of Freehold, Monmouth County, New Jersey. What early threatened to become a disastrous defeat for the Colonial forces was turned into a glorious victory by General Von Steuben. The retreating troops of General Lee were brought to a halt by Von Steuben and reformed under heavy fire. The retreating men knew how to conduct themselves and wheeled into line with the precision of veterans. What seemed to be a certain defeat turned into a patriot victory and a turning point in the war. This battle was followed by victories in Stony Point, Yorktown and other places.

Steuben was remarkable for the generosity and fineness of his nature, spending his entire income, beyond what was essential to his own simple needs, in purchasing clothing and rations for his men. In recognition of his services Congress granted him an annuity and New York State presented him with a large tract of land. He became an American citizen and lived in New York until his death in 1794. He was laid to rest in a hero's grave on his estate in Steuben County where the inscription on a bronze plaque sums up the contribution that he had made to the new nation "Indispensable to the Achievement of American Independence."

Steuben's military services in America are likewise very adequately indicated in General John McCauley Palmer's biography on Steuben by his most praiseworthy statement: "...in the course of my researches I was soon convinced that the military services of two men, and two men only, can be regarded as indispensable to achievement of American independence. These two men were Washington and Steuben. When I say that their military services were indispensable, I mean that each of them contributed something essential to final victory, that could not have been contributed by any other man in the American Army."

We found Animal House Shelter in Huntley, IL through a stray cat. The cat was microchipped (SO IMPORTANT!) and it was registered to the animal shelter. Because of this, we were able to reunite him to where he came from. He had gotten out 4 months earlier and travelled over 8 miles, from Lake County to McHenry County by some odd miracle.

We had finally agreed to our daughter Athena's request for a dog (she had been asking for 5 years).

First, we filled out the paperwork - a lot of paperwork. Then we had to decide what we wanted in a dog. Not an easy task, as we all wanted something different. Athena

wanted something small. She had been terrified of large dogs for years. But also something that does not jump. I thought something older, maybe even a little trained. My husband wanted a younger dog that was trained or a puppy.

So, one afternoon, we headed to the shelter thinking "This is going to be EASY!" After 3 hours and 12 dogs, we walked out with nothing. We were all so disappointed. There were a couple of dogs we would have been happy with, but not one did we fall instantly in love with.

We decided we would come back on Saturday morning, when they were releasing 4 litters of puppy to be adopted. We had to get there early to put our name on a list, because there is usually a crowd waiting for newly released puppies at the shelter. We were number 5. We returned 3 hours later when they opened and there were approximately 50 people standing outside waiting to meet the newest puppies. Some people we talked to drove for 2 or more hours to be there.

When our turn came, we glanced at the 3 litters that were set up in the "Visiting Rooms" and found her instantly! "Tisha" she was called. The runt of the litter, cute as can be, she was standing next to her much larger brother. My daughter knew right away - "That one!" We named her Tisha Bear.

She has been home for a week now. She is 11 weeks old. Potty training. Crate training. And so much fun! It's great being able to give Tisha Bear a forever home.

Bicycle Safety

As a reminder to residents, the State of Illinois and the Village of Skokie have specific laws to protect pedestrians, motorists and cyclists.

- By Village Ordinance, riders under the age of 16 must wear a helmet.
- Obey all traffic signs and markings.
- No more than two cyclists may ride side by side.
- Cyclist can ride on Skokie sidewalks, minding pedestrians, except for the B5 Downtown Business District. (Oakton Street from Skokie Boulevard to Lockwood Avenue, extending north and south on Lincoln Avenue between Cleveland Street and Babb Avenue.)

Other Village of Skokie bicycle safety suggestions include:

- Plan your route.
- Always ride with the flow of traffic.
- Yield to others including animals.
- Wear bright or reflective clothing.
- Do not wear headphones, listen to I-Pods, or distract yourself with wireless communication devices.

Your Most Important Choice

When people think about estate planning, they typically think of who will get their possessions. Upon further thought, they recognize that the most important decisions they make will be the identity of trusted decision makers like guardians, executors, trustees, and

If the individual has a Will, an executor or personal representative is named in the Will to manage the affairs of the estate. This person has the responsibility of collecting all the assets of the person who has died, managing those assets, paying debts of the estate, and then distributing the assets to heirs or other beneficiaries.

A trustee is similar to an executor, except the trustee manages the assets of the trust rather than of the estate. Because trusts often remain in existence for many years, the role of trustee may be more important than that of executor.

An agent is the person you appoint under a power of attorney to make decisions for you in the event that you are not able to do so for yourself. The agent under a power of attorney for property will make decisions regarding the management of your financial affairs. The agent under a health care power of attorney (also known as an advance health care directive or health care proxy) will make decisions regarding your health care.

If you do not have a power of attorney, it may be necessary to appoint a guardian or conservator to make financial and health care decisions for you if you are not able to make them for yourself. In some states, a separate guardian or conservator may be appointed for the care of the individual and a different person appointed as the guardian or conservator of the property, or estate, of the individual during lifetime. You may appoint a guardian or conservator for your care in a power of attorney.

Guardians of minor children are "nominated" in the Will by the last parent to die. Guardians are "nominated" rather than appointed because the courts will give preference to the nomination but are not bound by it. If a court determines that the best interests of the child would be served by another choice, they need not heed your suggestion.

An example of this is the tragic case of Stephen and Sara Sherwood. Only nine days after his return from Iraq, Stephen shot his wife and then himself. This left his daughter an orphan. The authorities in Colorado placed the daughter in the temporary care of Sara's sister, Ginny, and her husband, who then sought to be appointed as guardians. Stephen's mother objected and sought appointment herself. The trial court looked to Stephen's Will, because he was the last parent to die. Stephen's will nominated his mother and the trial court considered itself constrained by that unless to do otherwise would have caused actual harm or danger. The Colorado Supreme Court reversed that decision and instructed the trial court to determine which choice would be in the best interests of the child. Many states also allow a child over a certain age, typically around age 13 or 14, to overrule the nomination of guardian in the Will.

While the nomination of a guardian is not a guarantee, it does allow you to give the court guidance, which it will use to make its determination. If all other things are equal, the court will heed your advice.

The nomination or appointment of trusted individuals to be guardians, trustees, or executors is the most important decision you can make with regard to your estate plan. These individuals are charged with carrying out your wishes, whether in raising your children, managing your assets, or making distributions. A qualified estate planning attorney can assist you in making these difficult choices and drafting documents to accomplish your goals.



Rachel Rockwell and the Drury Lane Theatre with "Sweeney Todd" have a musical masterpiece on their hands for their audience. What a production and what a cast!

The later productions of Stephen Sondheim have never been favorites but after seeing this production I have to agree he is a musical genius.

Kyle DeSantis and family along with the Van Lente family and artistic director William Osetek deserve a standing ovation for this production.

Rachel Rockwell as the show's director and choreographer along with the musical direction of Roberta Duchak, the scenic design of Kevin Depinet and the lighting design of Jesse Klug as well as the dialog coach of Jill Walmsley Zager along with many others are all exceptional.
