



Presidents' Day FEBRUARY 19, 2018

Washington's Birthday is a United States federal holiday celebrated on the third Monday of February in honor of George Washington, the first President of the United States. Colloquially, it is widely known as Presidents Day and is often an occasion to remember all the presidents, not just George Washington or Abraham Lincoln, whose birthday is also in February. The term "Presidents Day" was coined in a deliberate attempt to change the holiday into one honoring multiple presidents.

The day is also a state holiday in most states with official names including Presidents' Day, President's Day and Washington's and Lincoln's Birthday. Depending upon the specific law, the state holiday might celebrate officially Washington alone, Washington and Lincoln, or some other combination of U.S. presidents. Some states celebrate Washington and the third president Thomas Jefferson but not Lincoln.

History

The federal holiday honoring George Washington was originally implemented by an Act of Congress in 1879 for gov-

ernment offices in Washington (20 Stat. 277) and expanded in 1885 to include all federal offices (23 Stat. 516). As the first federal holiday to honor an American president, the holiday was celebrated on Washington's actual birthday, February 22. On January 1, 1971, the federal holiday was shifted to the third Monday in February by the Uniform Monday Holiday Act. This date places it between February 15 and 21, which makes the name "Washington's Birthday" in some sense a misnomer, since it never occurs on Washington's actual birthday, February 22.

The first attempt to create a Presidents Day occurred in 1951 when the "President's Day National Committee" was formed by Harold Stone Bridge Fischer of Compton, California, who became its National Executive Director for the next two decades. The purpose was not to honor any particular President but to honor the office of the Presidency. It was first thought that March 4, the original inauguration day, should be deemed Presidents Day. However, the bill recognizing the March 4 date was stalled in the Senate Judiciary Committee (which had authority over federal holidays). That committee felt that, because of its proximity to Lincoln's and Washington's Birthdays, three holidays so close together would be unduly burdensome. During this time, however, the Governors of a majority of the individual states issued proclamations declaring March 4 to be Presidents' Day in their respective jurisdictions.

An early draft of the Uniform Monday Holiday Act would have renamed the holiday to "Presidents' Day" to honor the birthdays of both Washington and Lincoln, which would explain why the chosen date falls between the two, but this proposal failed in committee, and the bill was voted on and signed into law on June 28, 1968, keeping the name as Washington's Birthday.

By the mid-1980s, with a push from advertisers, the term "Presidents' Day" began its public appearance.

In Washington's adopted hometown of Alexandria, Virginia, celebrations are held throughout the month of February.

Crossing Delancey performs Feb 2 to Feb 18

At some point in our lives, we all have to make a choice. Do we follow the path laid out for us by others or do we break from tradition and go our own way? This is the choice that Isabella faces in Crossing Delancey, a sly romantic comedy by Susan Sandler.

Crossing Delancey has charmed audiences for decades as it explores the bonds of family and

tradition; the culture clash of old East Side and new West Side; and the romantic benefits of a new hat. Isabelle Grossman is a young Jewish girl who is living the dream. She has a rent-controlled apartment in New York's upper West Side, a job at a prestigious independent bookstore, plenty of friends, and a handsome local author to



dream about. None of this matters to her Bubbie, however, a strong-minded, fiercely loving, traditional Jewish grandmother, who worries about single Isabelle, living alone in a room, like a dog! Unbeknownst to Isabelle, Bubbie hires a marriage broker to save the day -- and she is introduced to pleasant and unassuming Sam, who runs his own pickle stand on the Lower East Side. Isabelle does not believe she could have anything in common with a pickle man , but just as she seems to be getting the attention of Tyler Moss -- the highbrow writer after whom she has been hankering -- Isabelle is blindsided by Sam's subtle wit and wisdom. Can Sam persuade Isabelle to change her style, after all? Will Bubbie cleverly maneuver them together?

Crossing Delancey was written by Susan Sandler. It was first produced in 1985. In 1998, Sandler turned her play into a critically-acclaimed movie that starred Amy Irving and David Hyde Pierce. Jewish stage actress Reizl Bozyk made her only film appearance as Bubbie, recreating the role she played on Broadway.

Crossing Delancey stars Chicago actress Daniella Rukin as Isabelle. With Kevin Costello, Nat Kier, Debra Rodkin, and Anita Silvert in the role of Bubbie. It is directed by Joseph Jefferson Award-winner Stephen M. Genovese.

Crossing Delancey runs February 2 to February 18, 2018. Fridays and Saturdays at 7:30 pm, Sundays at 2:00 pm, with a matinee on Wednesday, February 14 at 1:30 pm. 

Students Kick Off Lunar New Year At Governor's Office In The Year Of The Dog, We Celebrate Loyalty, Bravery And Responsibility

Students from one of the Midwest's largest Chinese schools decorated the Governor's Office in preparation for the Lunar New Year.

For the second year in a row, the students from the Ray Chinese School, located in the Naperville/Lisle community, hung ornaments and artwork at the entrance to the governor's office as part of a Lunar New Year cultural exhibition. "Two thousand eighteen is the Year of the Dog. The Lunar New Year is celebrated during the second new moon after the winter solstice and falls on Feb. 16 this year. According to Chinese legend, Buddha asked all the animals to meet him on New Year's Day. He named the months in order of the 12 animals that arrived. During the Lunar New Year, families would travel near and far to gather and lavishly celebrate the end of the year and welcome in a new year. This will be the Year of the Dog, celebrating traits of the dog including loyalty, bravery and responsibility.

Adler Planetarium Announces the Return of Award-Winning Temporary Exhibition What Is a Planet? Opening February 16

Twelve years after its reclassification to dwarf planet, Pluto is still plagued by its lack of true planet status. if Pluto isn't a planet, then what is? What made the International Astronomical Union reclassify Pluto in 2006? On February 16, Adler's award-winning temporary exhibition, What is a Planet? will be returning to continue the conversation.

The accepted definition of a planet has changed quite a bit over the past 500 years. At various times, the term has been used to describe the Sun, the Moon, and asteroids. And would you believe that Earth—the most familiar planet of all—hasn't always been considered a planet?!

So how do you define a planet? As scientists learn more about how the Universe works, they make discoveries that don't fit neatly into old ways of thinking. In What is a Planet?, guests will discover that new approaches and perspectives in science can change how we define worlds near and far.

The exhibition addresses the most compelling questions in astronomy, like why Pluto is no longer a planet, in a fun, dynamic way, and demonstrates how new approaches and perspectives in science can help change our view of the Universe. In the exhibit, guests explore artifacts from the Adler's collections that show how "planets" aren't what they used to be, witness how astronomers and the media reacted to Pluto's reclassification in 2006, and discover what it requires to be a planet today.

• Learn what the current definition of a planet is and hear what Adler astronomers think of this current definition.

 Voice your opinion about Pluto alongside skeptics and space enthusiasts through an interactive voting poll in real-time.

• Explore artifacts from the Adler collections that illustrate the ever-evolving definition of a planet.

What is a Planet?, which had its first run at the Adler Planetarium from March 19, 2016-January 8, 2017, was awarded first prize in the 2016 British Society for the History of Science (BSHS) Great Exhibitions competition in November 2016. Qualifying exhibits needed to address the history of science, technology, or medicine, and were judged on audience experience including originality, clarity, design, and learning.

This temporary exhibition, which is included with general admission, will be open to the public February 16, 2018 through October 21, 2018.



Baby Boomer Children Working with Parents Who Have Hearing Loss

It's never easy when a parent has hearing loss. There are a number of challenges standing in your way, and many families tend to live with the issue longer than they should before getting their loved one the treatment he or she needs.

Some of the challenges children of aging parents face include:

1. The gradual progression of hearing loss — frequently, hearing loss happens slowly over time, which makes it harder for the person it's happening to become aware of the problem. A person may begin to unknowingly do things to compensate for the hearing loss, such as standing closer to those who are speaking, or turning up the TV louder (which is why a loud TV is one of the clear signs of hearing loss).

2. A desire for independence — it's perfectly natural for parents to want to maintain some level of personal independence. That may mean that they don't want to admit they are experiencing hearing loss and they may be hesitant to agree to go in for a test and treatment. They may also think that some amount of hearing loss is normal as they age and just want to live with it.

3. Worries about cost of treatment - parents may think that hearing aids would cost a significant amount of money and be worried that they can't afford the costs of treatment. That may lead them to ignore or minimize the importance

of their hearing loss.

4. Lack of familiarity with advances in the field — parents may remember the bulky hearing aids of days gone by and be hesitant to commit to wearing such a device. Of course, they may not know that modern hearing aids are a fraction of the size of the old ones and are made to fit into a patient's life much more seamlessly and conveniently.

One thing we do know is that again and again we've interacted with patients whose children have brought them in for a hearing test after having to do some convincing. In nearly every case, after the patient gets comfortable, reviews his or her options, and gets set up with a hearing device, they've reported dramatically improved quality of life. Their independence can be maintained as children know their parent is hearing optimally when at home or out.

Wondering how to approach the subject? • Start By Simply Asking

Ask your parent if they have had any problems hearing (in a non-threatening manner). Example: "When we were at dinner last night, I noticed you couldn't understand the waitress, is that correct?"

• Express Urgency for Treatment

Express urgency in getting hearing loss treated. Hearing loss can cause people to become isolated, depressed, and also have cognitive decline.

American Legion Post 541 and Post 806 held a joint remembrance ceremony of the 75th Anniversary of the Four Chaplains. It commemorated

the sinking of the USS Dorchester on February 3, 1943 when it was torpedoed by a German U-Boat off Newfoundland in the North Atlantic.

The four Chaplains,(Alexander D. Goode (rabbi), George L. Fox (Methodist), Clark V. Poling (Baptist) and John P. Washington (Catholic)) were among the 904 men aboard the Dorchester as part of a threeship convoy. The torpedo hit the ship's electrical



system causing complete darkness. As the men evacuated the rapidly sinking ship, the four chaplains offered calming counsel and gave life jackets to each person. When no life jackets remained, each Chaplain gave away their own life jackets.



HUNGARIAN CHICKEN PAPRIKASH

On Easter Sunday last year our family was gathered at my younger brother's house to celebrate and share a great meal and desserts. I was surprised when two of my nieces asked me for the recipe for Hungarian Chicken Paprikash. I assured them that I would give it to them. Sometime later I looked in three Hungarian cook books which I have in English, as well as in two more in German, and each one was different! It was very frustrating, and that is why I didn't give the recipe to the young ladies until Thanksgiving, along with a container of authentic "Szeged" Hungarian Paprika. Here is how I learned it from my mother:



Ingredients: Whole chicken, cut up; or chicken legs, or chicken tenders available at Aldi & other stores. Sweet Hungarian paprika (Szeged) or sharp if you so desire. Onion, garlic, sour cream, flour, water, and salt to taste.

Procedure: If you have a whole chicken, cut it up into pieces or use chicken legs, cut in half. Remove excess fatty skin, but leave on some of the less fatty skin. Anytime you use meat with bones in it, it will give you a more hearty flavor. Use a bit of olive or vegetable oil and brown the chicken on both sides, then set aside. Chop the onion & brown in same pan. When nicely browned, add the chopped garlic and paprika and stir constantly for about a minute. Use about 1-1/2 tsp. paprika. I suggest you measure it & then record how it turned out. If you're not sure, use less rather than more because you can always add some. Add about one cup of water (or enough to cover the meat) and stir. You can always add more if needed. Add the chicken pieces and salt lightly. Cover the pot and simmer until the chicken is tender, turning the meat over at least once. To finish the dish, use about 2 tablespoons of sour cream, which you have taken out of refrigerator so that it at room temperature, and stir in about the same amount of flour with only enough water so it is the consistency of gravy. Use your judgment, depending on how much gravy you need for the amount of chicken you have. When chicken is done, push pieces to one side & slowly add the sour cream mixture, stirring constantly. Keep the heat low and allow to thicken. Mix together with the chicken and keep stirring and then taste the sauce. Serve with homemade or bought spaetzle or pasta of your choice, cooked "al dente." Or, you can add peeled potatoes when the chicken is simmering. Test for doneness. Serve with a vegetable or salad of your choice. Good luck & enjoy!
